OFFICE MEMORANDUM

Subject :- Assured Career Progression Scheme (ACPS) for the State Government Employee

The undersigned is directed to say that instances have come to the notice of the Government that Senior Group 'D' employee(s) who have earlier been granted Extended Scale of Pay but no promotion as Duftry/Jamadar/Head Mali/Head Sweeper would be eligible for only one financial upgradation in terms of Assured Career Progression Scheme (ACPS) and shall be placed in the revised scale of 7100 - 13840. Similarly, Senior Group 'D' employee(s) who have earlier been granted the Extended Scale of Pay and later promoted to the next higher post of Duftry/Jamadar/Head Mali/Head Sweeper were also not eligible for any financial upgradation in terms of Assured Career Progression Scheme (ACPS) and therefore remained in the revised scale of 7100 - 13840. On the other hand, Senior Group 'D' employee(s) Junior to the above, who has neither been allowed the Extended Scale, nor promoted to the post of Duftry/Jamadar/Head Mali/Head Sweeper would, under the Assured Career Progression Scheme (ACPS), be entitled to two financial upgradations, i.e., 7100 - 13840 and later the next higher scale of 7700 - 15020. Cases such as these, have been under the consideration of the government for sometime past.

The Government of Meghalaya on the recommendation of the Anomaly Committee have now decided that as a special dispensation, the categories of Senior Group 'D' employees who have been allowed Extended Scale only, or Extended Scale and Promotion, shall be granted and placed in the next higher scale of pay of 7700 - 15020 with effect from the date his/her junior is/was granted the scale of pay of 7700 - 15020 and such placement shall be with prior concurrence of the Finance Department.
