


SPECIAL BULLETIN REGARDING INCIDENTS REPORT ON 29.2.2020 FROM
08.00 A.M. TO 6.00 P.M ARE AS FOLLOWS

1. 01(One) Akash Ali, 21 (twenty-one) years of age of Laban Batti Bazaar, was assaulted by a group of people at Jaiaw, Langsning today the 29.02.2020 at 11 A.m. The injured person has been admitted to Civil Hospital, Shillong. Matter under enquiry.
2. Today Non-Indigenous people whose names are indicated below were stabbed at Iewduh (Bara Bazar) Shillong. All were shifted to Civil Hospital, Shillong for treatment. However, Shri Rupchand Dewan succumbed to his injuries on the way to the Hospital. The names of the persons are as follows:-

X. **Shri Shubham Nath**, age – 18, S/o Shri Pintu Ranjan Nath of Lower Mawprem, Bishop Falls.

3. At 3.15 Pm received information that Shri Shubham Nath (18) S/O Shri Pintu Ranjan Nath of Bishop's fall Mawprem, Shillong was stabbed on his left shoulder and brought to Civil Hospital, Shillong with deep wound. Matter under enquiry.
4. At 3.20 pm one Non-Tribal (name not known) was assaulted by locals at Iew Sohra market. He was taken to CHC Sohra for treatment. The person received grievous injuries on his head, where he has later referred to Shillong Civil Hospital for further treatment. Matter under enquiry.
5. Curfew was imposed today (29.02.2020) from 12.00 Noon until further orders in areas under Lumdiengjri PS and Sadar P.S.
6. Based on an FIR lodged by KSU, a case has been registered in Shella PS Vide Shella PS Case No. 9(12)2020 U/S 148/326/506/307/302/34 IPC and sec. 3 of PDPP Act and the following persons were arrested in connection with the above noted case and investigation is still on. Names of arrested person(s) are as follows: -
