

CIRCULAR NO 10/2013

It has been observed that certain seized properties like Vehicles, Arms & Ammunitions etc are being utilized by the Police personnel. These properties are essentially case properties and should be deposited in Court for keeping in malkhana/in its custody and using as evidence during trial. Misuse of these properties can have serious legal implications.

The Superintendents of Police should ensure that seized properties such as vehicles, arms and ammunitions etc are not be utilized by the Police when entrusted for safe custody.
