**CIRCULAR No. 6, dtd. 27.7.2014**

All directly-recruited Cadet Sub-Inspectors (UB & AB) shall be on probation for a period of two years from the date of joining service. After successful completion of their probation period, they shall be confirmed in the service by the Appointing authority as per Rule 39, of the Assam Police Manual part-III.

No leave, except casual leave, will be permitted under ordinary circumstances during the probationary period of the Cadet SIs.

The Training Department shall maintain a record of the compulsory training programs completed by each Cadet Sub-Inspector (UB & AB) during the probation period. The period of leave availed, other than Casual leave, and the training programs missed by any Cadet SI due to such leave availed, shall be brought on record.

Any probationer who has not undergone any compulsory training programs due to leave or other reasons during his/her probation period shall have his/her period of probation extended to that extent of leave availed till the probationer completes the missed training portion.

A written order from the Training Department indicating the period extending the probation shall be served on the Cadet Sub-Inspector (UB&AB).

If during the period of probation, a probationer who fails to undergo the requisite training course or passes the requisite department examinations, or who has not been on duty/training for at least 90 % of the probation period, his/her period of probation may be extended by such period or periods as may be necessary subject to the condition that the total period of probation does not exceed to double of the prescribed period of probation, except in the cases where the CSI was :-

- (a) Under suspension;
- (b) Against whom disciplinary proceedings are pending ; or
- (c) Against whom prosecution for criminal charge is pending.



A probationer who has completed the period of probation to the satisfaction of the Appointing authority, shall be confirmed against a Substantive Post by the Appointing authority. The confirmation order shall be placed in the Service record of the officer concerned.


