

Awareness Programme on Cyber Crime
Cyber Forensic Training Facility, Golflink, w.e.f. 18th-22nd May, 2015.



A week long awareness programme was conducted at CFTF, Golflink, Shillong, on “Cyber Crime”. A detailed report on the same is hereby submitted as follows:

1. General aspects

The week long awareness programme held on cyber crime and various issues, aimed at imparting elementary knowledge to police officers and police personnel from various districts of the state on the below noted topics:

- (i) Overview of Cyber Crime
- (ii) Basics of a computer system and identification of its peripherals
- (iii) IP Address and Email Basics
- (iv) Networking in computer systems
- (v) Features of ITAA 2008 and legal provisions for digital evidence
- (vi) Cyber Security Practice and ethical hacking
- (vii) Tracking and tracing of emails and practical demonstration
- (viii) Basics of digital evidence and search and seizure of the same
- (ix) Social networking sites and issues related to Law Enforcement Agencies

- (x) Mobile phone basics. Crimes related and investigation of the same
- (xi) CDR/SDR analysis and related cases review
- (xii) Demonstration of cyber forensic tools
- (xiii) Case studies related to cyber crime.

Resource persons engaged in the programme included Faculty members from Information Technology Department, NEHU, Shillong, Technical Officer from National Informatics Centre, Shillong, Advocate from Shillong Bar Association and Police Officers from various Wings and Branches of the Department. The learning approaches, structures and activities were aimed at enabling the trainees to enhance their ability to tackle the increasing trends of cyber crimes and to incorporate the same in their respective working backgrounds.

2. Participation

Altogether 20 (twenty) participants cum trainees took part in the said programme, from various districts of the state excluding 3 (three) districts which include West Khasi Hills, East Garo Hills and North Garo Hills. Each district had sent 1 (one) participant each except for East Khasi Hills (2 [two] participants). The participants also included 10 (ten) personnel including officers of Cyber Crime Wing (CCW), SCRB organization.

The participants fully attended and were participative and satisfied with this awareness programme. All the sessions were delivered in PowerPoint presentations by the resource persons and the same was handed over to them as soft copies written in data discs. The participants were quite interested in the topics and showed keen interests especially in the practical demonstrations. They were even more motivated in seeking more knowledge about their doubts relating to practical field experiences. All this reflected a strong participation, support, and cooperation from the trainees towards the success of the programme
