No.HPL.3/2014/179 - In exercise of the power conferred by sub-Section (1) of Section 21, read with the proviso to Sub-Section (4) of section 29 of the Meghalaya Police Act, 2010 as amended, the Government of Meghalaya is pleased to make the following rules further to amend the Meghalaya Multi-purpose Task Force Rule 2014, namely :-

1. **Short title and commencement** – (1) These rules may be called the Meghalaya Special Force (hereinafter referred to as MSF) (Amendment) Rules, 2016.  
(2) They shall come into force at once.
2. **Amendment in preamble** – In the fourth line of the preamble to the principal Rules, the words “Multi Purpose Task” and abbreviation “MMSF” shall be substituted by the words “Special” and “SF-10” respectively and wherever the words “Multi Purpose Task” and “MMSF” occur, the words Meghalaya “Special Force 10” or “SF-10” shall be substituted.
3. **Amendment of Rule 1.1** – In rule 1.1 of the principal Rules, the word “Multi-purpose” shall be omitted
4. **Amendment of Rule 3** – In rule 3 of the principal Rules, for the existing sub-rule 3.1, the first two lines “There shall be the Meghalaya Multi Purpose Special Force (MMSF) which shall be known as Special Force 10 or SF 10” shall be substituted by the words “There shall be the Meghalaya Special Force 10 or SF-10”.
5. **Amendment of Rule 4.1** - In Rule 4.1 of the principal Rules, in the third column of the table under the heading physical measurements, the present specification for height shall be substituted by the following :

Male - 157 centimeters for Scheduled Tribe candidates including other Scheduled Tribes;

Male – 162 centimeters for others;

Female – 152 centimeters for Scheduled Tribe candidates including other Scheduled Tribes;

Female - 157 centimeters for others.

6. **Amendment of Rule 7** – In rule 7 of the principal Rules, in the existing sub- rule 7.2, the words “ other battalions of” shall be omitted.
7. **Amendment of Rule 8** – In rule 8 of the principal Rules, for the existing sub-rule 8.1, the following new sub-rule 8.1 shall be substituted, namely,-

“8.1 All the ranks including the followers, but other than the ministerial staff and medical staff while serving in SF-10 shall be entitled to a special allowance at the rates as indicated below:

8. **Amendment of Rule 9** - In rule 9 of the principal Rules, for the existing sub-rule Rule 9.1 the following new sub-rule 9.1 and 9.1A shall be substituted, namely:-

“9.1 (1) A SF-10 Battalion shall have the following specialized units for special Operations :.

(i) Commando

- (a) Urban  
(b) Jungle

(ii) Riot control and law and order

“9.1 (2) The specialized units as referred to in sub rule 9.1 (1) shall be constituted as follows out of the sanctioned strength of Commandos:
