Discussions, Decisions & Observations	
<p>Presentation started with the above dignitaries:</p> <p>The following points were commented after the presentation.</p> <ul style="list-style-type: none"> • The DGP asked whether citizen services like passport verifications, missing persons, car theft etc. Can be incorporated in the Core Application Software (CAS). Office Management System may also be included the CAS. SPMC team stated that this feature has been included. • ADGP (HQ) asked whether modules have been provided to take care of file movement and e-procurement through e-quotations. SPMC team confirmed that this is being looked into. • The issue of data entry at various police officers was discussed whether this issue wouldn't come 	

into the success of CCTNS. It was clarified that the issue had already been raised at NCRB and the Core Application software which is being developed at the centre level will be very user friendly. Also the System Integrator will take special care into this matter while customising the software at the state level.

- It was discussed that the implementation of the CCTNS would be done in 3 phases and the timeline for each phase is 1 year as per the guidelines of NCRB. The first phase will start from the date the SI will be selected.
- ADG (CID) was of the view that resource change and replacement of consultants which were not as per guidelines is not acceptable. It was agreed by SPMC to look into the matter.
