**C I R C U L A R N O. 4 0 / 2 0 1 1 .**

In order to ensure that investigation in cases of murder, rape, dacoity and robbery is carried out expeditiously and strictly along professional lines, apart from supervision by CIs/Inspector OCs, investigation in all such cases must be closely supervised by GOs also and written supervision notes must be given by them. Also, follow up action taken on instructions contained in supervision notes should be closely monitored. This is necessary in order to ensure that in all such cases culprits are brought to justice without unnecessary delay. While supervising investigation in the cases, it should, inter alia, be checked as to whether the CDs are being written regularly.

Henceforth, Superintendents of Police should submit following information to the respective DIGs (Range) with copies to this office as well as to ADGP (CID) and ADGP (L/O) at the end of each month:-

(I).	Names/Rank of the G.O in the District	Number of cases supervised by each GO during the month	Number of cases in which he/she gave supervision notes.
(II).	Name of C.I/Inspector O/C	Number of cases supervised by each CI/Inspector O/C during the month.	Number of cases in which he/she gave supervision notes.
