CIRCULAR NO.4 DT. 21-2-2013

In exercise of the power conferred on the Director General of Police vide Rule 12 of the Meghalaya Police Relief & Welfare Fund Rules, hereafter referred to as fund, Rule 11 will be amended by addition of the following Sub Rule:-

Sub-Rule 11.1: Where a police personnel remains untraced for a long period of time after departmental inquiry that is instituted to find out the whereabouts of the said missing personnel, if it is found out that it is not a case of desertion, on receipt of application from the next-of-kin of the personnel who has gone missing, the Central Police Welfare Board can extend a one time financial assistance not exceeding Rupees Twenty five thousand from the Central Police Relief and Welfare Fund depending upon the financial condition of the family. This will however be subject to the condition that in case the concerned police personnel subsequently resurfaces; the amount of financial assistance will be recovered from him without interest.
