**CIRCULAR No. 2/2012(PE)**

It has come to the notice of the Police Headquarters that there have been a number of unauthorised construction of temporary structures within the premises of Police land. Such constructions have created problems for the Department as whenever the Department plans for expansion of accommodation and other facilities, evicting the occupants of such constructions becomes difficult and at times the Department has to take recourse to legal remedy. The Heads of the Districts/Units/Organisations are therefore directed to take immediate steps to remove unauthorised constructions from the Govt. premises under their control to avoid aforesaid situation. If necessary, legal remedy may be sought wherever required, to evict and dismantle the unauthorised constructions.
