No. LJ(A) 77/2000/240 – For the purpose of the Rules for the Administration of Justice and Police in the Khasi and Jaintia Hills, 1937 and of the Khasi Syiemship (Administration of Justice) Order, 1950, the Governor of Meghalaya, with the approval of the Hon'ble High Court of Meghalaya, is pleased to appoint the following Judicial Officers, as the Assistant to Deputy Commissioner, East Khasi Hills District and further under rule 17 and paragraph 4(2) of the aforesaid rules and orders, invest them with the powers of the Judicial Magistrate of the First Class as defined in the Code of Criminal Procedure, 1973 within the East Khasi Hills District excluding Sohra (Civil) Sub-Division with immediate effect. However, any appeal, from Sohra (Civil) Sub-Division will lie with the court of Additional Deputy Commissioner, (District & Sessions Judge) Shillong.
