



Dated, Shillong the 25<sup>th</sup> September, 2014.

No. LJ(A) 77/2000/Pt/73 – In exercise of the powers conferred under rule 1-A of the Rules for Administration of Justice and Police in the Khasi and Jaintia Hills, 1937 and further under sub-section (1) of Section 2 of the Meghalaya Autonomous Districts Administration of Justice Act (Assam Act XIV of 1960 as adapted and amended by Meghalaya), the Governor of Meghalaya, with the approval of the Hon'ble High Court of Meghalaya, is pleased to invest Smti C. Dkhar, Additional District & Sessions Judge, Shillong as the Additional Deputy Commissioner No. 2, East Khasi Hills District for the trial of all offences punishable with death, imprisonment for life or imprisonment for a term of not less than five years under the Indian Penal Code or under any other Law for the time being applicable to the District and also to hear all Civil and Criminal revisions, appeals, etc. from, the decisions of the Assistants to the Deputy Commissioners within the said District and the Governor is further pleased to direct that such Additional District & Sessions Judge as Additional Deputy Commissioner No. 2 shall for the purpose aforesaid, exercise all the Judicial powers of the Deputy Commissioner No. 2 within the said District including Sessions cases of Sohra (Civil) Sub-division with immediate effect.

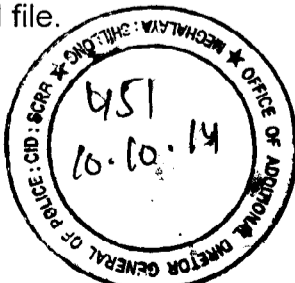
