No.HPL.215/2013/91 – With the revised Cadre structures of the Meghalaya Police Services duly recommended by the 4th Pay Commission and consequential amendment of Rule 4 (2) of the Meghalaya Police Service Rules, 1990, it has become necessary to determine the eligibility of the rank and badges to be used by the Meghalaya Police Service officers in the Selection Grade scale of pay (Non-functional).

2. After careful consideration of all aspects and without prejudice to the seniority in the category of Senior Duty posts, the Governor of Meghalaya is pleased to specify that the Meghalaya Police Service Officers promoted to Selection Grade (Non-functional) in the pay scale of Rs.28,700-860-35580-1050-43980/- shall continue to use the same rank and badges without collar tabs and there will be no change in the rank badges of such officers.

3. This order will come into force with effect from the date of this notification.
