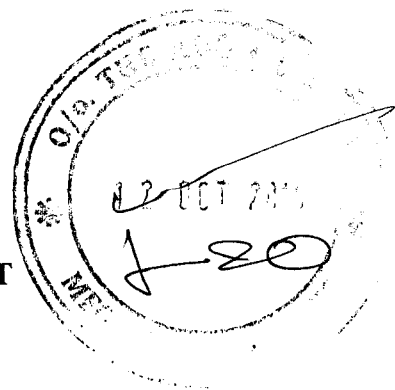

The duty and function of the Board are as follows :-

- (a) To advise the State Government on any matter connected with Animal Welfare or the prevention of infliction of unnecessary pain or suffering on animals.
- (b) To advise the State Government on the making of relevant rules under the Prevention of Cruelty to Animal Act, 1960.
- (c) To co-operate with, and co-ordinate the work of, associations or bodies established for the purpose of preventing unnecessary pain or suffering to animals or for the protection of animals and birds.
- (d) To give financial and other assistance to animal welfare organizations functioning in any local area which shall work under the general supervision and guidance of the Board.
- (e) The Board shall be reconstituted every three years from the date of the reconstitution.
- (f) The Board shall meet atleast twice in a year and form its own rules regarding conduct of meeting etc.
