Subject : Fixation of Pay for Constable from Non-matriculate to Matriculate Scale.

Sir / Madam,

With reference to the subject cited above, I am directed to inform you that Govt. in the Finance (PR) Department was consulted vide this office L/No. FM/XXVI-I/10/278 dated 18th February, 2016 (copy enclosed) regarding '*Fixation of pay for constable from non-matriculate to matriculate scale*'. In its reply vide letter No. F(PR)-146/2009/Pt/87 dated Shillong the 25th February, 2016 it says, *that fixation of pay of under-matric Constable in the Matriculate Scale for passing HSLC should be under F.R. 23(ii) of the Meghalaya FRs & SRs which say that 'when appointment to the new post does not involve assumption of higher duties and responsibility an employee will draw as initial pay the stage of the time scale which is equal to his pay in respect of the old post, or, if there is no such stage, the stage next below that pay, plus personal pay equal to the difference and the period which it was drawn may be counted for increment in the same stage. But if the*

minimum pay of time scale of the new post is higher than his pay in respect of the old post, he will draw the minimum as initial pay' (copy enclosed)

Relevant documents of Finance vide No. F(PR)146/2009/Pt/81 dated 21st September, 2015 is enclosed herewith as a sample case.

Therefore, as per Govt. of Meghalaya, Finance (PR) Department, fixation of pay for such cases must be strictly followed to avoid complications in future.

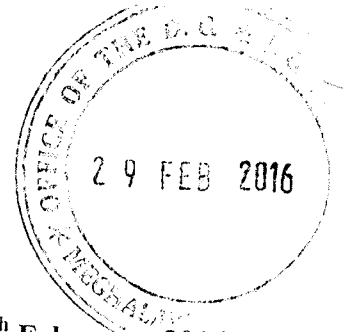

With reference to your letter cited above I am directed to say that fixation of pay of under-matric Constable in the Matriculate Scale for passing HSLC should be under F.R.23(ii) of the Meghalaya FRs & SRs which says that "when appointment to the new post does not involve assumption of higher duties and responsibility an employee will draw as initial pay the stage of the time scale which is equal to his pay in respect of the old post, or, if there is no such stage, the stage next below that pay, plus personal pay equal to the difference and the period which it was drawn may be counted for increment in the same stage. But if the minimum pay of time scale of the new post is higher than his pay in respect of the old post, he will draw the minimum as initial pay."

Hence, the pay of Shri Molinath Sangma fixed at ₹3380/- + ₹20/- Personal Pay in the matriculate scale of 3100 – 5650 on 30-5-1996 under the provision of F.R.23(ii) is in order.
