  - (a) Earnest Money of Rs. 5000/- in the form of Cross Bank Draft or Call Deposit pledged in favour of the Superintendent of Police, (F&ES), Meghalaya, Shillong.
  - (b) Attested copy of valid Trading License in terms of the United Khasi & Jaintia Hills and Garo Hills (Trading by Non-Tribal) Regulation, 1954 for Non-Tribals.
  - (c) Attested copy of recent Passport size photograph of the Tenderer.
  - (d) Attested copy of PAN Card of the Firm / individual.
  - (e) Attested copy of ST certificate for Tribals.

- 9. The undersigned reserves the right to reject any or all the Tenders without assigning any reason thereof.


