No.HPL.148/2012/5 - In exercise of the power conferred under section 47(2) of the Meghalaya Police Act, 2010, the Governor of Meghalaya is pleased to notify a General Review Committee consisting of the following members :-

- (i) Chief Secretary, Govt.of Meghalaya;
- (ii) Principal Secretary to the Govt. of Meghalaya, Home (Police) Department;
- (iii) Director General of Police, Meghalaya;
- (iv) Commissioner & Secretary/Secretary to the Govt.of Meghalaya, Political Department;
- (v) Secretary to the Govt.of Meghalaya, Law Department.

2. The terms of reference of this Committee shall be as follows:

- (i) The Committee shall make recommendations to the Government for posting and transfer of officers from the level of Inspector General of Police and upto the level of Addl. Director General of Police.
- (ii) It will also review functioning of the Police Establishment Board, general superintendence of the provisions of the aforesaid Act and coordinate matters of prosecution in the State.
- (iii) The Committee shall also function as Appellate Authority against the decisions of the Police Establishment Board and orders of the Police Headquarter.
