The term of office of the members other than those who are members ex-officio and the manner of filling vacancies referred to in Clauses (d) and (e) of sub-sections (1) and the procedure to be followed shall be such, as may be prescribed.

The members (except members ex-officio) shall be entitled to receive such allowances in respect of expenses incurred in the performance of their duties as may be prescribed.

The Board shall meet twice a year at such place as the State Government may direct.

The Board shall regulate its own procedure (including the quorum).

Duties of Wildlife Advisory Board.

It shall be the duty of the State Board for Wildlife to advise the State Government;-

- (a) In the selection and management of areas to be declared as protected areas.
- (b) In formulation of the policy for protection and conservation of Wildlife and specified plants.
- (c) In any matter relating to the amendment of any Schedule.
- (d) In any other matter connected with the protection of wildlife which may be referred to it by the State Government.
