

## MISSION STATEMENT

We strive to adopt what is legally and ethically right or proper and shall be fair to all parties as directed by reason and justice.

We strive to be free from favouritism or self interest or bias by conforming to the established laws and procedures.

We strive to rise to the emerging challenges by adopting scientific methods and technology for excellence in policing.

### Objectives of the Police Department

The primary Objectives of the Police Department are as under:

1. To emerge as the trusted, dependable and resolute Law Enforcement Agency of the State;
2. To maintain public order through Community participation;
3. To collect and communicate actionable intelligence affecting the public peace and tranquillity;
4. To prevent the commission of offences and public nuisances;
5. To detect and bring offenders to justice by adopting scientific methods and technology and
6. To apprehend all persons whom he is legally authorized to apprehend with absolute respect to Human Rights.

### The Functions of Police Department:

The role and functions of the police shall broadly be:

1. To uphold and enforce the law impartially, and to protect life, liberty, property, human rights, and dignity of the members of the public;
2. To promote and preserve public order;
3. To protect internal security, to prevent and control terrorist activities, breaches of communal harmony, militant activities and other situations affecting Internal Security;
4. To protect public properties including roads, railways, bridges, vital installations and

establishments etc. against acts of vandalism, violence or any kind of attack;

5. To prevent crimes, and reduce the opportunities for the commission of crimes through their own preventive action and measures as well as by aiding and cooperating with other relevant agencies in implementing due measures for prevention of crimes;
6. To accurately register all complaints brought to them by a complainant or his representative, in person or received by post, e-mail or other means, and take prompt follow-up action thereon, after duly acknowledging the receipt of the complaint;
7. To register and investigate all cognizable offences coming to their notice through such complaints or otherwise, duly supplying a copy of the First Information Report to the complainant, and where appropriate, to apprehend the offenders, and extend requisite assistance in the prosecution of offenders;
8. To create and maintain a feeling of security in the community, and as far as possible, prevent conflicts and promote amity;
9. To provide, as first responders, all possible help to people in situations arising out of natural or man-made disasters, and to provide active assistance to other agencies in relief and rehabilitation measures;
10. To aid individuals, who are in danger of physical harm to their person or property, and to provide necessary help and afford relief to people in distress situations;
11. To facilitate orderly movement of people and vehicles, and to control and regulate traffic on roads and highways;
12. To collect intelligence relating to matters affecting public peace, and all kind of crimes including social offences, communalism, extremism, terrorism and other matters relating to national security, and disseminate the same to all concerned agencies, besides acting, as appropriate on it themselves;
13. To take charge, as a police officer on duty, of all unclaimed property and take action for their safe custody and disposal in accordance with the procedure prescribed.

# DAWKI POLICE STATION

**D**awki Police Station is one of the oldest Police Stations in the state. It was inaugurated on the 11<sup>th</sup> of January 1994 by the then Director General of Police, Shri D.N.S.Srivastava, IPS and it is located at the central trading hub of Dawki village, a location setup not far, about 200 meters approximately from the International Border.

Dawki village is popularly known for its picturesque location with a multitude of tourist flocking the area annually. It is also the main trading Hub between two friendly

nations India and Bangladesh. There are three main tourist destinations within Dawki PS jurisdiction viz. Umngot Dawki Boating Point, Shnongpdeng and Darrang.



Dawki Police Station shares both international and domestic borders, with East Khasi Hills in the West, East Jaintia Hills in the East and Bangladesh in the South.

The Station since its 26-years inauguration saw only minor repairs and the staff quarters were even commiserating. Hence, the year 2019, with the valuable assistance an active support of the Hon'ble Superintendent of Police, West Jaintia Hills, has witnessed several developmental projects done only on a self help basis such as:

- a. Refurnishing the lock up and merging it with the general room.
- b. Construction of the 2<sup>nd</sup> O/C room.
- c. Repairing of the aged obsolete septic tanks and drain field pipes.
- d. Improving and enlarging the station compound.
- e. Construction of a new main entrance gate to the PS building.
- f. Construction of an additional 2000 liters water reservoir.
- g. Refurnishing the SF-10/ BN Langar by installing drainage pipes.
- h. Rewiring of the entire office building.
- i. Painting of the exterior portion and interior office building.

Moreover, charitable donations from assorted sympathizers were handed out to

the PS like plastics chairs, ropes, boulders for constructing and repairing the station, etc. Dawki PS has further donated 8 Nos of plastic seats to the Office of PSI Amlarem Court. With an unfenced border, it entails a heightened risk of the continuous influx of

goods and illegal migrants into the region but owing to the constant effort from various agencies like the BSF, Infiltration Department, SIB, Customs, and the VDPs, etc. matters concerning National/potential

State threat are rigorously monitored and checked.



***Police Lock-up***

In the year 2019, Dawki Police Station has voluntarily undertaken several innovative initiatives at the grassroots level to adequately train and equip the VDPs and headmen with sundry matters concerning Law and Order, combating various other anti-social elements such as crime against women, domestic violence, etc. These were imparted by organizing numerous meetings in the year 2019. Community Policing is undoubtedly the backbone of the Police Station and will continue to be so; practical difficulties of villagers and VDPs are candidly discussed on every frequent visit made by any villager or VDP at the Station and necessary suggestions/help rendered on how to combat likely problems faced by them.

Dawki remains a trading hub between India and Bangladesh that typically has major traffic congestion where daily hundreds of trucks from West Jaintia Hills and East Khasi Hills are bottlenecked, thus resulting in queuing of vehicles from Tamabil Gate to

Dawki Umngot River and Nongtalang village. In March of this year, the matter was taken up diligently by this Police Station, and a meeting was held at Dawki Police Station between the BSF, leading exporters of various associations from both West Jaintia Hills and East Khasi Hills Districts to find a solution to the menace that has in common been a boon to the public at large. The meeting yielded fruitful results and since then, the traffic at Dawki and neighboring villages has drastically improved. Frequent meetings on other essential aspects were convened throughout the year between the Customs and exporters alongside the Police to facilitate the free flow of traffic along the border.

The BSF and the Police have a close relationship and have detected and solved

various crimes occurring in the area such as smuggling of cattle, dry pea, apprehending of illegal immigrants, etc. There were instances where Indian nationals were abducted by Bangladeshis into Bangladesh and were safely retrieved by the BSF after holding flag meetings between the two neighboring countries.

With the increase in public meetings, the outcry of the general masses were heard and laid out and accordingly a course of action were incorporated and this paved way to extended public and police relationship, to eliminate the primary source of social evil, vice raids and foot patrolling along with villagers, among others were executed to curb the menace of illegal selling of liquor which acts as the root cause of numerous social crimes.

On the 5<sup>th</sup> of June, 2019 to mark the notable occasion of World Environment Day, an auspicious campaign was efficiently conducted between the local villagers and the police to



sensitize the profound need of the hour by planting trees to safeguard the environment.

Daily night mobile patrolling is being conducted, and the tangible result is indicative of the gradual decrease in the number of thefts that were reported at the Police Station.



### ***Patrolling***

On the 14<sup>th</sup> of November, 2019 Dawki Police enthusiastically celebrated Children's Day with local children from diverse schools, and sensitization was brought about on the paramount issue of Child

Labour, POCSO Act and various other aspects of Children related crimes.

Last but not the least, I would genuinely like to express my heartfelt gratitude to the entire staff of Dawki Police Station for making 2019 an apparent success, their diligence, discipline, and support has been all but lacking. Their valuable contribution has been magnificent and extraordinary. Dawki Police Station has now received many compliments and words of praise from the public for their hard work and determination to go the extra mile to accomplish a task. But still, various other areas undoubtedly require improvement and we are extremely sanctified to be endowed with a very dedicated, approachable, sincere group of seniors who offers relentless support at every juncture of our journey both in professional and personal life.

# AN INSIGHT INTO THE ANTI NARCOTICS TASK FORCE (ANTF), WEST JAINTIA HILLS DISTRICT

**A**s per the report of NORTH EAST INDIA DRUGS AND AIDS CARE (NEIDAC) the number of drug addicts in Meghalaya has increased considerably from 2,000 in 2004 to 17,833 in 2009. Such increase has taken place over a period of just five years, all of them are from the rural sectors which included 5398 from Jaintia Hills. According to the report 30% of addicts in the state of Meghalaya are from Jaintia Hills District. The reason for the highest number of drug addicts and those affected by it is because of easy access and availability of illegal drugs.


Myanmar is the second largest illicit opium producing country in the world. Needless to say, this significantly influences the entire

North-East region.

According to the UNODC's report on Drug Use in the North Eastern States, (UNODC 2004) stated that drug trafficking in Northeast India features the smuggling of heroin into Northeast India from Myanmar in small quantities. Narcotic Crime Bureau (NCB), Guwahati have provided a map showing NH-44 as one of the main trafficking route of contrabands coming from Myanmar to North East India and mainland India.

The total number of drug user registered at MCSWA, Jowai till October 2019 for the Needle and syringe exchange program (NSEP) is 250 and for Opiate Substitution Therapy (OST) are 204.

### ORGANIZATIONAL PROFILE



**Members:** The Anti Narcotics Cell, Jowai was constituted on 31.07.2016 with one officer of the rank of Sub Inspector and one Constable. The CELL operates under the direct supervision and control of the Superintendent of Police, West Jaintia Hills District.

**Function:** The sole purposes of the Cell are as follows:

- To combat illicit trafficking of drugs and psychotropic substances
- Prevent drug abuse and
- Educating public against drug abuse.

Later on 27<sup>th</sup> July 2018, the cell was revamped to cope with the growing

problems of drug abuse in the District. hence in light of the above the cell was later renamed **“The Anti Narcotics Task Force”** now having the total strength of one Nodal Officer of the rank of Deputy Superintendent of Police and a team consisting one Sub – Inspector, one head Constable and six constables all functioning under the direct supervision of the Superintendent of Police, West Jaintia Hills.

### VISION AND PHILOSOPHY

The vision of the Task Force is to ultimately make West Jaintia Hills District a Illicit Drug free District. Therefore the role of ANTF as a Law Enforcement agency is to focus and ensure supply reduction.

### OBJECTIVES

With the rapid increase in supply and drug abusers especially amongst the youths in the district, apart from the objectives of Combating illicit trafficking of drugs and psychotropic substance, preventing drug abuse and Educating public against drug abuse the task Force also further aims and endeavors to

- Sensitize police personnel about the drug laws and important legal procedures to be observed when dealing with such cases.
- Facilitate in the sending of willing Drug addicts/abusers to specialized rehabilitation centers in the region.

## ACTIVITIES

The activities of ANTF with regard to the supply and demand reduction of illicit drugs in the district are as follows:

### *Supply reduction*

Keeping in mind our objectives a total of 17(Seventeen) cases under NDPS Act have been registered since 2016 and a total of 37 (Thirty Seven) peddlers have been arrested till date.



### *Demand reduction*

It is felt that it is equally important to intervene and prevent the vulnerable youths from indulging themselves in this bad habit of abusing drugs. As part of our efforts to combat the drug problem, we

would also like to shift our focus to early intervention and prevention of youth from drugs abuse whereby the Task Force has initiated a campaign entitled “**Positive Addiction Campaign**”.

### *About the positive addiction campaign*

Addiction to drugs is a negative addiction. The best way to combat this negative addiction is to provide the youth something else that is positive to get addicted to. As part of our efforts to combat this drug menace, we initiated the **POSITIVE ADDICTION CAMPAIGN –FUTSAL FOR CHANGE 2017** on the 10th-11th February, 2017 at U Kiang Nangbah Football Stadium.



The two days event was a combination of sports, music, food, auto-expo with the main attraction being FUTSAL. Participants



to the campaign included 32 localities from in and around West and East Jaintia Hills Districts. The campaign was a grand success whereby we were able to generate maximum awareness through Pre- event promotions which have been done using the local dailies as well as social media such as Facebook etc. Post- event coverage was disseminated through local media outlets such as The Shillong Times etc, national newspaper such as India Times and through online digital media like Wyrta, Riluk, The Northeast Today etc.

***Awareness programs***

Many awareness programs have been conducted in various school, colleges and localities within the district. Further a campaign video in collaboration with students of Thomas Jones College was released and uploaded as part of the International day against drug abuse 2017.

## PHRAMER TRAFFIC CELL

The initiative for activating the Phramer Traffic cell was taken by Shri C.Syrti MPS, the then Deputy Superintendent of Police (Hqr), Jowai under the supervision of Shri O.Pasi, IPS the then Superintendent of Police during the erstwhile Jaintia Hills District and function under Jowai Police Station. The land measuring Length 169 feet, Breadth 65 feet, Total 10,985 feet was donated by the village of Phramer-Thadmuthlong and Pasyih village as a Gift Deed to the Meghalaya Police Department on the 25<sup>th</sup> January, 2010 and the construction work was started on the 19<sup>th</sup> March, 2010 and it started to function on the 7<sup>th</sup> June, 2010 and it was officially inaugurated on the 5<sup>th</sup> October, 2011 by Shri D.K.Rapthap, IPS, Inspector General of Police (ER) Meghalaya, Shillong.

The Traffic Cell located at Phramer village is situated on the NH-6 and at a junction where vehicles coming from Shangpfung, Lad Rymbai and



Jowai. It is at a distance of 8 KM from Jowai Police Station and the traffic situation in and around Phramer requires urgent attention as the area has become a commercial spot as trucks and vehicles coming from Lad Rymbai, Shangpfung and Jowai stop here for various activities.

### **Awareness Programme**

An awareness programme on “Community Policing” was convened at Phramer Traffic Cell on the 8th



January, 2018 wherein the Headmen and Secretary of different villages were present to discuss on how to prevent crimes and to tackle Law & Order situation

especially during the Assembly Election, MDC and MP Election 2018/2019.

The VDP of different villages were given awareness to help the police locate and trace out miscreants of any specific localities especially in serving Process to the Warrantees, Witnesses, Accused Person etc.

An awareness programmes was also conducted in schools in the presence of Child Line staff on the crime against women and children and on POCSO Act. Also, on request of many schools’ head, delegates were sent to different schools for teaching them March Past on the occasion such as Republic Day, Independence Day and school sports day etc.

### ***Social Activities carried out by Phramer Traffic Cell Police.***

On the 5<sup>th</sup> February, 2019, the Road Safety Day was observed at Phramer village at Shangpung junction in which the respected DTO Jowai was the Chief Guest in the presence of the police and VDP members. In the function, awareness on road safety such as obeying the traffic rules etc. was inculcated to the general public.



On the 3<sup>rd</sup> May, 2019 UBC/157 M.I.Lyngdoh and ABC/115 M.Lathong along with Bn, personnel were deputed to attend the program to revive the VDP at Kyndongtuber village in which the staff graced the



occasion as a Chief Guest. In the program, the newly elected members of the VDP were all present and they were apprised of their duties and responsibilities and how to work hand in hand with the Police. A football match was also organized on the day by the new VDP which was witnessed by the villagers.

On the 2<sup>nd</sup> October, 2019, along with the rest of the nation, the Gandhi Jayanti was observed at the Cell premise by conducting tree plantation along with the VDP members.

# ANTI HUMAN TRAFFICKING

**H**uman trafficking is basically the trade of humans for the purpose of forced labour, sexual slavery, or commercial sexual exploitation for the trafficker or others. Trafficking in persons is



a serious crime and a grave violation of human rights. Human trafficking involves recruitment, harboring or transporting people into a situation of exploitation through the use of violence, deception or coercion and forced to work against their will. It is estimated that internationally there are between 20 to 40 million people in modern slavery today. Assessing the full scope of human trafficking is difficult because many cases so often go undetected, something the United Nations refers to as “the hidden figure of crime.” Only a small percentage of survivors of human trafficking cases are identified, meaning that the vast majority of cases of human trafficking go undetected. It is

estimated that 71% of enslaved people are women and girls, while men and boys account for 29%.



In Meghalaya, it is common that minor girls go missing for a couple of days and then comes back to the family; hence the families usually do not inform the police in the first instance. Many of the minor girls go missing with their boyfriends and are back with their parents after 2-3 days. Parents are indirectly aware and society has considered this a norm. While, in most of the cases, it is love affair that is the reason that results in sexual relations with her boyfriend, often ending up with early motherhood. But the worry has to be that this can be a potential case of human trafficking mainly for sexual exploitation.



The District Police has a special Anti-Human Trafficking unit, which has cracked many such cases of minor girls getting entrapped for sexual exploitations. The team has their informers and works at blazing speed 24X7, but has to mainly wait for a case to be filed. The delay in filing the case by the parents is their biggest hurdle, as in this time frame, the victim may be transported to a geographically faraway place making it difficult for the police to help recover the victim and crack the case.



The adolescence age combined with puberty results in love, sexual relations and also ignites an illusionary faith in the self that nothing bad can happen to them. Many a times, these kids then take extreme steps under peer pressure or are victimized towards such actions. While some have ended up being impregnated and few as young single mothers, an unknown number of these kids have ended up into the world of prostitution, sexual labor and are sexually exploited. Hence, parents and society as a whole needs to address these issues on a daily basis.

In a recently solved case by the Anti Human Trafficking Unit, the parents reported to the police after a week since the minor girl went missing and the girl was a habitual run away for 2-3 days. The Police when starting their investigation noted other similar instances of minor girls missing in the vicinity. With the use of information from mobile companies the Police could trace links and the case progressed. On receiving information from a girl, the Police set a trap and proceeded in civil dress and were able to crack the case which involved many minor girls being sexually enslaved and were regularly supplied to clients in Jowai, Shillong and adjoining areas. Around 15 girls were rescued, the pimps and their network was exposed and all arrested.



The 14 other girls were able to be rescued because the parents of one girl reported and the case progressed. It helped expose and break a network that could grow big and would have entrapped many minor girls in the future.

It is important that parents, teachers and the society at large to keep our young minor girls and boys informed about such instances. Awareness is the key to prevent them from falling into the trap. They need to be strengthened in life skills to make their decisions of love life and sexual activity. Imposing ideals or curtailing freedom may result in them being a rebel, which would be dangerous. A dialogue, counseling and friendly approach is the best approach to combat the ills of society.

Hence in general they are the eyes and ears of the Police and a stronger relation will lead to a stronger bridge.



**World Environment Day:** In today's world of deteriorating environment a small step

towards green revolution is becoming much of a need and as a small gesture, self SI R.

Syngkon and all the available personnel had planted approximately 35 numbers of different species of plants at the Outpost compound. All personnel took active participation in planting tree saplings and I


and healthy. The physical exercise was imparted by C/Operator S.Kr.Rabha attached Battalion Personnel at Saphai Outpost.

# ASSAM MEGHALAYA BORDER ISSUES

The border issues between Meghalaya and Assam are not new and the problems have been faced by the people living in the border areas and the state as a whole during the last four decades. West Jaintia Hills shares its interstate border with Assam; to the North with West Karbi Anglong District and to the East with Dima Hasao District.

The district is having border issues with West Karbi Anglong District and the areas under difference between the two districts generally comes under Block-I. One of the areas is Moolaber, Psiar areas which falls under Raliang Police Outpost and the other is Khanduli areas which fall under Saitsama Police Outpost. The border issues have been experienced year after year and various stakeholders have tried to resolve these issues and till date an amicable settlement of the issues is yet to be achieved.

These incidents have been widely reported in the print and electronic media. In this brief note on border issues, the following extracts from



media reports about the border related issues experienced in West Jaintia Hills during the year 2019 are briefly elaborated below in chronological order:

Every year during winter season, the villagers of Khanduli went to collect fire wood from a forest called Khlaw Samantho and Langmih within the Elaka of Dolloi Nongjngi and on 04.02.2019 while the villagers went to the said forest they were stopped by 14 Forest Guards of Assam who warned them not to cut the trees and collect the firewood from the forest. Later the matter was taken up by the District Administration of West Jaintia Hills with the District Administration of West Karbi Anglong and situation was calm down.

On 07.03.2019 an FIR was submitted at Saitsama Outpost by the Headman and Secretary of Khanduli village, regarding the construction of road at “Langhuh” by Assam Govt. which is under Khanduli village.

Enquiry was conducted and found that the construction work was started a month ago and bulldozers were used for earth cutting. The work was implemented by the PWD, Govt. of Assam under PMGSY Scheme and the road planned to connect Tahpat and Khanduli village. The construction work was later stopped.

On 27.03.2019 the Karbi people from Assam came to a place called “Pdein Langhuh” which is under Khanduli village and make a demarcation by marking “TDL” on the trees and at the same time draw a boundary line by digging the earth. The boundary line is inside Khanduli village and approximately 700 metres from the boundary line made by the Khanduli villagers. On received of the information, the Headman of Khanduli village along with the villagers went to the area and removed the demarcation marked “TDL” on the trees. However, prior to this, the people of Khanduli on 11.03.2019 went to the above noted place and re-erect the boundary pillar uprooted by Assam few

months back and dug a boundary line about 50 metres away up to the road connecting to Lapangap village.

On 04.04.2019 one JCB was found dressing the road from Musyiem to Mokoiram which is approximately 100 metres from Khanduli village. On getting the information, the people of Khanduli under the leadership of the Headman and Secretary went to the spot and stopped the work. It is also learnt that the construction work was carried out by the people of Mokoiram and not by the Assam Govt.

On the first week of May 2019, road construction work was started at Mokoiram village by Assam and during such construction the Assam counterpart came to dig and carry the earth from Langwei area which falls under Khanduli village and transported the same to Mokoiram for the construction purposes without the knowledge of the Dorbar Shnong of Khanduli village. Hence, the same was opposed by Khanduli village.

On 14. 05.2019, the Assam officials stopped the villagers of Lapangap while they were repairing the Kutcha road from Lapangap to Khanduli as they stated that the area falls under the disputed area and no construction work should be undertaken without the knowledge of both the Deputy Commissioners of the two districts. The work was later stopped.

On 28.05.2019 the Headman of Psiar and Khatkhasla village reported that the laborers from Assam were escorted by Assam Police and came to a place called lurim Biam which is about 2 Kms approx from the main road of Psiar village and 5 Kms approx from Mokoilum Outpost (under Assam) and leveled the land. It is suspected that the Assam Govt. is planning to construct a Border Police Outpost in the area.

On 12.06.2019 the Assam counterpart started to construct a suspected Border Police Outpost at lurim Biam in a place

where they have leveled the land previously in the month of May 2019. In view of this, the Deputy Commissioner, West Jaintia Hills

spoke with his Assam counterpart and on the 13.06.2019 the Assam Police have withdrawn all their forces from lurim Biam and have also removed all the construction materials.

On 29.06.2019 the Assam officials led by the Chief Executive Member of Karbi Anglong Autonomous Council (KAAC); Deputy Commissioner, West Karbi Anglong; Superintendent of Police, West Karbi Anglong and other officials from Assam conducted an inspection near the Myntang River and claimed that the Myntang River is the natural boundary between Assam and Meghalaya. Such claim by Assam has resulted in serious objection from various quarters.

On 07.07.2019 the Assam Govt. started the construction of road in Lapangap village, a disputed area and sought to connect Tahpat with the main road that leads to Khanduli through Lapangap village. The same was intervened by the border Magistrate of Meghalaya and the construction work was

asked to be stopped till the matter is resolved between the district administrations of West Jaintia Hills and West Karbi Anglong districts.

On 22.07.2019 the Headman of Khanduli alleged that the Assam Police Battalion who were in full arms were harassing vehicles from Khanduli village. As per reports from the villagers of Khanduli, they also alleged that such illegal harassment by Assam Police Battalion happens regularly.

On 19.08.2019 about 6-7 villagers of Khanduli went to a forest called “Langwieh” which belong to the Khanduli Dorbar Shnong with a view to transport the pine logs that were illegally cut down by some unknown persons. However, while returning they were detained by the Assam Police from Mokoiram and taken them to their Battalion camp. Immediately the

border Magistrate from Meghalaya rushed to the spot and after negotiation with the border Magistrate of Assam, the detained persons were released.

In September 2019, the Jaintia Hills Autonomous District Council (JHADC) leased a forest land called “Khliehlanghuh” under Khanduli village to one successful bidder and on 02.10.2019 while the laborers of the bidder went to fell the trees from the said forest, the forest officials from West Karbi Anglong district arrived at the spot and directed them to stop their work and claimed that the area falls under the jurisdiction of Assam. In this regard, a meeting between the Officials of West Jaintia Hills and West Karbi Anglong was held and during the meeting they have decided that the matter will be taken up at the Deputy Commissioner’s level of both the districts and felling of trees will be stopped for the time being.

In November 2019 reports was received that the road construction from Tahpat to Khanduli which was started by Assam Govt. in the month of February 2019 is in progress and during such construction, the villagers under Lapangap village where the road

construction is undertaken has been badly affected as the road is passing through the

central part of the paddy fields of Lapangap village.

On 04.12.2019 a complaint was received from the Dorbar Shnong of Khanduli village that the Assam Govt. is planning to construct a permanent Battalion camp at Khanduli (Lumpyrdi) village. Enquiry was conducted and the matter has been taken up by the Deputy Commissioner, West Jaintia Hills with the Deputy Commissioner, West Karbi Anglong to stop the construction work in the area.

On 09.12.2019, the bidder of the leased forest at Khliehlanghuh under Khanduli again sent his laborers to the forest to fell down the pine trees and during felling of trees, the laborers were apprehended by the Assam forest officials and later released them.

The above are the various border issues that have occurred and took place in the border areas of the district during the last one year. These problems kept on repeating

every year and the people living in these border villages have to bear the consequences. Hence, it is the need of the hour to find a permanent solution to these long pending border issues so that the people of both the states will live in peace.

The aim of this article is to highlight the problems faced by people of both sides of the interstate border. To solve these, regular meetings between the OCs and ICs of the bordering Police Stations and Outposts have been held. The Deputy Superintendents of Police of both neighboring districts are also in constant touch with each other to diffuse any tense situation along with the border Magistrates. The Deputy Commissioners and Superintendents of Police of both the districts have also met each other to chalk out various strategies to solve such problems at the local level.

**J**owai Police Station is one of the oldest Police Stations in the state. Earlier Jowai Police Station was of Assam type building and the new building was inaugurated on 6<sup>th</sup> June 1988 by the then Hon'ble Deputy Chief Minister of Meghalaya, Shri D.D.Lapang.

Before, Jowai Police Station was the only Police Station of the then united Jaintia Hills District in which Jowai was the then capital but after the bifurcation of the district into East Jaintia Hills and West Jaintia Hills, Jowai remains the capital of West Jaintia Hills. Jowai Police Station is located at the main market of West Jaintia Hills, **lawmusiang.**



The market attracts the public and it can be easily located. In the

same building of Jowai Police Station there are Women Police Station, Jowai Traffic Branch, Anti Narcotic Task Force and Police Control Room. Under



Jowai Police Station jurisdiction there are Jowai Women Police Station, Jowai Traffic Branch, Ummulong Beat House, Phramer Traffic Cell, Raliang Police Outpost and Saphai Police Outpost.

Jowai town is surrounded by the beautiful Myntdu River and under Jowai Police Station there are many tourist spots viz., Syntuksiar which is famous for Kiang Nongbah monument and picnic spot and

# CYBER CRIMES OVERVIEW

Information Technology and the Internet have led to create new ways for malicious person to perpetrate crimes. The perpetrators range from sophisticated hackers to common criminals and international terrorists. Cyber threats are increasing for governments, commercial enterprises and industry and to ordinary citizens.

Cyber crime is the latest and perhaps the most complicated problem in the cyber world. Cyber Crime can be a threat to National Security as well as financial stability. Modern world is the era of



information technology where computers, laptops and internet have become a necessity. This technological advancement in the world has changed the crime scenario as crime is no more limited to the conventional methods. Cyber Crime has no geographical boundaries and it has become a challenge to the Investigating Agency.

Any criminal activity that uses a computer either as an instrument, target or a means for perpetuating further crimes comes within the ambit of cyber crime.



Cyber crime encompasses a broad category of offences, some types of cyber crime are:

**Online lottery frauds/ Online job frauds:** In this type of offence, innocent people are contacted by the fraudster through both SMS and Email communication stating that they have won huge amount in lottery or got lucrative job offer. Slowly, in the name of customs, anti- terrorism, conversion, NOC, VISA processing, etc., incremental money will be asked to be deposited in



bank accounts which are created with fake credentials. Mostly people from foreign

origin (like Nigerians) are indulging in such offences. The money lost by the victims runs into crore of rupees. On the same analogy people are being targeted and cheated in the names of jobs abroad.

**Cyber Stalking /Online harassment:** Cyber Stalking is one of the most widespread net crimes in the modern world. The word "stalking" means "pursuing stealthily". Cyber stalking can be used interchangeably with online harassment and online abuse.



**Online cheatings:** Criminals are using matrimonial sites and other advertisement sites with false content to lure innocent victims again mostly female, thereby cheating them for wrongful gain and blackmailing.

**Fake online appointments in reputed multi-national companies:** For such offences, cyber criminals access the details of people whose resume is posted on different online job portals with their personal details. Using those details, the

cyber criminals contact them and offer jobs and collect money in the name of processing fee, etc.

**Phishing frauds:** In this line, cyber criminals contacts people in the guise of popular banks, Income Tax Department, Webmail service providers, such as Gmail, Yahoo Mail, etc., and send messages asking the targets to part with their security credentials such as username, password, account information, date of birth, etc., so that they can hack into those accounts for wrongful gain.


**ATM, Debit and Credit card frauds:** These are all possible both online, by collecting the PIN numbers, CVV numbers, and offline, by cloning the card.

**Hacking:** The term Hacking has broad connotation, but in Cyber it means unauthorized access. There are several ways and means used by these fraudsters to compromise computer security, bank accounts, mail accounts, websites and web servers for defamation, wrongful gain, cheating, stealing of personal data. In hacking cases, targets could be individuals, companies, nations or critical infrastructure.



**Publishing of obscene content /pornography:** This is also one type of online harassment, wherein victims share their intimate pictures, videos with people who manage to come very close to them and, at a later time, if some issues arise between them, the victims are targeted by publishing their personnel/ private videos, in the net.

**Cyber terrorism:** The most deadly and destructive form of cybercrime is "cyber terrorism". The traditional concepts and methods of terrorism have acquired new dimension. In the age of information technology, terrorists have acquired expertise in producing the most deadly combination of weapons and technology,



which, if not properly checked without delay, will take a heavy toll on the society. The damage, so occurred would be almost irreversible and most catastrophic, in nature. In short, we are facing the worst form of terrorism, popularly known as "Cyber Terrorism". The expression "cyber terrorism" includes an intentional negative and harmful use of the information technology which has both national and

international ramifications on the economic, industrial and strategic fronts.

**Morphing:** Change smoothly from one image to another by computer animation techniques.


**Data Theft:** If any person without permission of the owner or any other person, who is in charge of a computer, computer system of computer network - downloads, copies or extracts any data, computer data base or information from such computer, computer system or computer network including information or data held or stored in any removable storage medium, then it is data theft.

**Identity Theft:** Identity theft is a form of fraud or cheating of another person's identity in which someone pretends to be someone else by assuming that person's identity, typically in order to access resources or obtain credit and other



benefits in that person's name.

**E-Mail Spoofing:** E-mail spoofing is sending an e-mail to another person in such a way that it appears that the e-mail was sent by someone else. A spoof email is one that appears to originate from one source but actually has been sent from another source. Spoofing is the act of electronically disguising one computer as another for gaining the password system. It is becoming so common that you can no longer take for granted that the e-mail you are receiving is truly from the person identified as the sender.

The Ummulong Police Beat House also shares its jurisdictional boundaries with other Police Stations like Mawryngkneng Police Station in East Khasi Hills District, Nartiang Police Station and Jowai Police Station in West Jaintia Hills District and the National Highway is also under the lookout of Ummulong B.H starting from Wah Mynso Village up to Khliehtyrshi Mookyniang Village (Jowai Bye Pass).



Ummulong Village is situated on the NH-6 and it is at a distance of 13 Kms from Jowai Police Station. The traffic situation on the National Highway running through the jurisdiction of the Ummulong Police

Beat House requires urgent and prompt attention as it is the main thoroughfare for the public coming from other states as well as local residents of the state of Meghalaya.

## DAWKI POLICE CHECK POST (PCP)

The Dawki Police Check Post (PCP) is located at Tamabil-Dawki and is about 50 metres from the International India-Bangladesh border. The PCP was established since the year 1953 and till date is operating from the Land Customs Station building. It is regarded as one of the oldest Land ICPs in the country. During the initial period (1953) the PCP was



mostly used by Indian and Pakistani nationals for entering and exiting Bangladesh (then East Pakistan). As per the

1953-54 passenger data maintained at the PCP, the average flow of passengers (incoming and outgoing) is as listed above.

Of late the flow of passengers has seen a surge especially in the last 2-3 years and is likely to increase further as the tourism sector in Meghalaya has also start booming up. At present the average flow of incoming and outgoing passengers is about 200-300 per day during off seasons and around 500-600 passengers during peak seasons.

### Functioning of the PCP

The PCP since its inception serves as one of the important Land Immigration Check Post that caters to international traffic. The primary function of the PCP is to regulate the entry (arrival), stay and exit (departure) of foreign nationals in the country. The PCP also caters to matters relating to repatriation and deportation of those nationals who have illegally entered/overstayed in the country or otherwise.

## Mode of Operation

The PCP till date maintains the Arrival/Departure details of passengers manually in different registers viz.

1. Outgoing Register of Bangladesh nationals
2. Arrival/Departure of Bangladesh nationals
3. Diplomatic/Official registers of Bangladesh nationals
4. Indian Arrival/Departure register
5. Incoming register of Indian nationals
6. Diplomatic/Official register of Indian nationals
7. Arrival/Departure Register of Nepal nationals
8. Outgoing register of Nepal nationals
9. Arrival/Departure register of foreign nationals
10. Outgoing register of foreign nationals
11. Arrival/Departure of Bhutan nationals
12. Diplomatic/Official register of foreign nationals



The above-mentioned registers are maintained manually due to poor network connectivity and erratic power supply at the PCP. Besides, the equipments like Passport Reading Machine (PRM), Biometric machine and Webcam etc provided to the PCP are yet to be put to use due to the above encumbrances.

### Training imparted

The staffs deployed at the PCP are yet to be imparted any training in immigration matters related to proper handling of the said equipments including updating of passenger records in the IVFRT database system.

## HUMAN TRAFFICKING: A REVIEW ON THE RECENT SEX TRAFFICKING RING UNEARTHED AT WEST JAINTIA HILLS DISTRICT, MEGHALAYA

Human trafficking, a form of modern slavery is a grave violation of human rights. Every year thousands of people, men, women and children around the world are being coerced, cheated and forced into some form of labour, slavery or illegal commercial sex through aggression, intimidation and deception. Though quite a number of studies have been held in the western countries to understand the causes and outcomes of human trafficking but the number of such studies is limited in India and especially very inadequate in the state of Meghalaya. It is very important to get an idea of the stakeholders who work for the prevention of Human Trafficking. It is also pertinent to remember that trafficking affects both men and women, with a higher fraction of trafficking occurring in women and girls. Women and girls face brutal torture and appalling physical abuse, sexual abuse, mental abuse within the vicious circle of trafficking. People who lure them into this are none but their own relatives and friends in the majority of cases. They fall prey to false promises and their all around development is curbed in every manner. There should be alternative livelihood opportunities devised for them, so that they won't be forced to step out of their homes and be victimized in this manner.

Hence, when the Anti Human Trafficking Unit of West Jaintia Hills District Executive Force, Meghalaya Police, unearthed a sex trafficking ring which included minors in the

district, it is imperative to look into the causes of why these innocent people fall prey to the traffickers and how this menace can be curbed. Thus, the ultimate aim is to bring down these incidents of human trafficking by finding the root cause and striking at it with the most fitting solution to reduce their occurrences. Along with this, the role of all stakeholders should also be highlighted upon and the gaps persisting should be bridged. It is



important to encourage people participation at the grass root level to ensure solutions to this quandary be formulated from the source.

## OBJECTIVES OF THE STUDY

To examine the main factors of human trafficking, to examine experiences of the victims of human trafficking taking the recent human trafficking case in West Jaintia Hills District as a case study and to examine the role of all stakeholders in combating human trafficking, as well as the shortfalls in curbing this menace.

## WHO ARE THE STAKEHOLDERS?

**Law Enforcement Officials:** The law enforcement agencies are the prime stakeholders in preventing human trafficking, as well as investigation and prosecution of cases related to human trafficking. These include the Magistrate



who is empowered to direct any police officer not below the rank of Sub Inspector to rescue a person if he believes that the rescue is required, the state police with the designated Special Police Officer, Special Juvenile Police Unit and Anti Human Trafficking Unit, the Border Security Force, Railway Protection Force and the Criminal Investigation Department.

**Post-rescue Care Providers:** They provide the rescued victim the opportunity to move on to a life of dignity and respect by empowering them and prevent them from

further exploitation and neglect. These include the District Legal Service Authority for provision of legal support and funds for repatriation, the Child Welfare Committee, the District Social Welfare Department, The State Commission for Women as well as the State Commission for Protection of Child Rights, the District Child Protection Unit, Child Line and NGOs.

**Counsellors:** Counselling helps the trafficked person to move out of trauma. A trafficked person who is counselled well is



able to move forward and undertake a life of dignity. These include government medical officials trained in the field, NGOs, Child-Line, etc.

**Medical Professionals:** The District Medical Health Officer along with other medical officers under his/her office of a district can provide immediate medical care and attention as well as mental relief to the victims of trafficking.

**NGOs:** NGOs can facilitate Law Enforcement Agencies in ensuring conviction of offenders by providing adequate information and intelligence against any person or persons suspected of human trafficking, in identifying vulnerable pockets or areas and transit points of trafficking thereby helping

the police to arrest and prevent such crimes. NGOs can also work with victims of trafficking by making them aware of their basic rights.

**The Community:** A strong, well networked community acts as deterrence against human trafficking and sexual exploitation. This can only be achieved by having an active participation from all the Dorbar Shnong of the district, the Village Defence parties, the youth as well as every single individual of the society. Moreover, respectable members of a community can be independent witnesses to such cases.

**Family Members:** Broken homes and careless parents are one of the major factors which lead to exploitation of children and women. Most trafficked victims have had a difficult family life as children. Therefore parental care and attention are important aspects in preventing violations of child rights and child trafficking.

#### **BRIEF OF THE CASE:**

On the 2<sup>nd</sup> June 2019, the West Jaintia Hills-District Executive Force (WJH-DEF) were able to rescue several minors who are victims of human trafficking based on the information received on the disappearance of one minor girl vide GDE No 03 Dated 02/06/2019. Due to the efforts led by the OC Women PS Jowai, WPSI Smt Ibashisha Kharpran, officers and staff of Women PS, Special team, WJH-DEF and SF10 to locate the missing girl and based on the information received through reliable sources, a sex trafficking ring was uncovered on the 3<sup>rd</sup> June 2019 wherein the WJH-DEF were able to arrest 8 people.

Information was then received from reliable sources on the 4<sup>th</sup> June 2019 that two more persons were involved in procuring minor girls for prostitution. Again on the 9<sup>th</sup> of June, 2019 another two persons involved in procuring minors were arrested based on reliable source information. In this regard, till date, a total of 25 persons have been arrested and 15 chargesheeted in connection with the above case so far.

#### **EFFORTS OF WJHD AHTU TO UNEARTH THE TRAFFICKING CASE:**

Missing Report case was filed by the mother of the missing girl. Based on this information, the OC Women PS Jowai, West Jaintia Hills District immediately swung into action with her team to locate the missing girl at the earliest. Sources were engaged for any reliable information. All efforts were made to find clues to her whereabouts. The last phone call she made to her boyfriend was recovered and the tower location and CDR were immediately taken out of the last number she called whereby it led to more evidence relating to the trafficking ring.

Throughout the process, the OC Women PS engaged officials from district CHILDLINE to ensure that on recovery of the missing child, she is handed over to the appropriate authorities for all formalities to be observed and necessary action be taken.

Throughout the investigation of the missing child case, the officers engaged in the case left no stone unturned to gather more evidences which in turn led to more clues of a sex trafficking ring which included minors. During the process of enquiry, the Superintendent of Police, WJH-DEF was kept informed of the course of

development of the case the whole time for advice and directions.

Information which led to the discovery of more minor victims in the trafficking ring was due to the gentle but persuasive questioning and building of trust by the officers and the rescued trafficked victims. All efforts were made that none of the victims rescued were treated poorly and that their self-respect was not harmed.

Intel collection played a vital part in breaking the case. Throughout the investigation, intelligence collection and reliable source information were one of the major sources which led to the breakdown of the trafficking ring.

The Child Welfare Committee, District Child Protection Unit and the District Social Welfare Officer of the district were immediately informed about the case. All rescued victims were sent for medical care and handed over to the appropriate authorities for counseling and rehabilitation.



The arrest of all accused persons in this case was a collaborative effort of the officers and staff of women PS, the Special team, Special Force 10 as well as reliable sources.

## CASE STUDY OF THE TRAFFICKED VICTIMS

Most of the victims have stated their lack of financial status in their families which led them to flesh trade. Since majority of them come from the weaker sections of the society, they were easily lured by the traffickers onto joining the trafficking ring with false promises and high hopes.

Another victim stated that lack of employment and financial crisis at home led them to join the flesh trade so as to provide for the family.

Another stated that the promise of huge amounts of money and lavish lifestyle blinded her to join the trafficking ring.

Most of the victims either are illiterate or school drop outs. In this regard, most of the trafficked victims stated that this was the only way to be financially independent.

Majority of the victims are runaways from their homes stating the lack of understanding and support from their families which led them to join the flesh trade.

Another victim replied that she couldn't go back to her family for fear of being rejected by her family and the society.

Most victims have addressed their fear that even after being rescued, there is no choice for them to lead normal lives as they have nothing to look forward to.

## **CURRENT EFFORTS TO COMBAT HUMAN TRAFFICKING IN WEST JAINTIA HILLS DISTRICT.**

Presently, Meghalaya has Anti Human trafficking Units in four districts, East Khasi Hills District, West Jaintia Hills District, West Garo Hills District and Ri Bhoi District, while efforts are being made to set up the Unit in all other remaining districts as well.

West Jaintia Hills District has only one CHILDLINE service to cater to the needs of children related issues like that of Child Trafficking. In relation to this the District Child Protection Unit and Child Welfare



Committee also work in tandem to provide rehabilitation and counseling to trafficking minors. The rehabilitation facility available is one shelter home only for minors. One Anti-Human Trafficking Unit (AHTU) is also functional in West Jaintia Hills District.

## **CHALLENGES FACED COMBATING HUMAN TRAFFICKING.**

Lack of financial help during rescue activities. No financial scheme has been provided to the AHTU for assistance to the trafficked victims after rescue. When these trafficked victims are rescued by the AHTU, there is no immediate aid for provision of basic necessities to them in the form of food, warm clothes, etc.

No immediate assistance was given by the social welfare department for the adult victims. In addition to this, there is no shelter home for adult victims present in the district for rehabilitation.

Medical facilities provided for victims, including minors is not sufficient. During medical examination, the medical officer in attendance may give a more detailed and comprehensive report in the findings to help with investigation in the case.


Counselling of victims including minors can be done in a more sensitive way with strict regards to maintain the dignity of the victim.

There is no awareness among the general mass about identifying the symptoms of trafficking and such vulnerable situations when they must act upon. Hence all stakeholders of human trafficking can take a proactive approach to educating the masses

and remove the stigma associated with rescued trafficked victims.

Short term rehabilitation of those who get trafficked and restoring their lives and basic human rights is not enough for their survival. These victims need cultural friendly and sustainable schemes to aid their sustenance.

Lack of support to people who get trafficked is a major setback as they are not easily accepted back into the society when they are sent back after the rescue operation.



Therefore, rehabilitation schemes should be designed by the state government for long term aid to these victims of trafficking.

The increase rate of school drop outs also correlates to the increase incidence of child trafficking, therefore the education department along with the CWC and the DCPU can take steps to minimize this trend and provide awareness to the young.


#### **RECOMENDATIONS:**

To prevent human trafficking, creating awareness to all sections of the society must be undertaken by all stakeholders, governmental bodies as well as NGOs by working together, thereby filling the gap between them.

Proper financial schemes should be provided for assistance to rescued victims, after the rescue operation and proper legal support throughout the rehabilitation process.

Creation of more shelter homes both for adult and minor victims, so that they can be properly rehabilitated. Proper counseling is mandatory in such cases. A trafficked person who is counseled well is able to move forward and undertake a life of dignity.

Proper medical aid and facilities should be



provided to the victims of trafficking especially those afflicted with HIV and other forms of STDs.

Identifying the importance of NGOs in combating Human Trafficking is crucial. NGOs can facilitate Law Enforcement Agencies in ensuring conviction of offenders

by providing adequate information and intelligence against any person or persons suspected of human trafficking, in identifying vulnerable pockets or areas and transit points of trafficking thereby helping the police to arrest and prevent such crimes. NGOs can also work with victims of trafficking by making them aware of their basic rights. Immense priority should be given for allotment of resources to those nodal agencies, NGOs, civil societies and governmental bodies who are involved in anti-trafficking activities in all the districts of the state.



Vulnerability mapping should become a mandate to identify the pockets which are more vulnerable. The major issues prevailing in these pockets should also be identified and then measures should be devised to tackle these issues.

Educating the people about their rights and thus empowering them is the need of the hour.

Social workers can help trafficked victims in the process of capacity building so that they can have access to better services in their own region. Their contribution towards alleviating poverty, removing disparities, increasing access to basic needs makes social workers accountable to these sections of the society.

Educating the communities and families of all sections in the district is vital as broken homes and careless parents are one of the major reasons leading to exploitation of minor children. A well informed community can act as deterrence against human trafficking.

# MUKTAPUR PATROLLING POST

**M**uktapur Police Patrol Post was established vide Govt. Notification No. HPL-526169/40-A Dtd 4.6.1982. A plot of land measuring 1449 Sq meter for Muktapur PPP was donated by Durbar of Muktapur village on 16.6.1987 and construction of U/S Quarter and L/S Quarter was completed on 30.12.1989 and 28.3.1990 respectively. Muktapur PP falls under Dawki Police Station and functioning with one Sub-Inspector as In-Charge, one Head Constable, six UB constables, one driver and one MPRO operator. Muktapur jurisdiction is bordering with Khliehriat PS, East Jaintia Hills District on the East, Amlarem PS on the North, Dawki PS on the West and Bangladesh to the south.

**Prevention & Detection of crime:** Muktapur PP jurisdiction is located in the extreme border with neighbouring country

Bangladesh. There is very less crime reported at the PP and some cases of theft involved by Bangladeshis remain unreported.



Most of the cases are Cattle cases which registered on the strength of Court Order under section 11 Prevention of Cruelty to Animal Act. The VDPs and village durbar are active at Muktapur village which help in prevention and detection of crime. Cases of petty offences are solved by the village durbar and VDP. Regular joint patrolling with VDPs is conducted at Muktapur PP.

**Activities:** Main activities under Muktapur PP are the investigation of crime against Cruelty to Animal under section 11 Prevention of Cruelty to Animal Act. There are more than 90 cases reported at Muktapur PP by BSF regarding Cruelty to Animal and the same were registered at Dawki Police Station till date.

**Performance:** Regarding performance in the investigation of cases, all cases against Cruelty to Animal ended in Final Report, since no one could claim to be the owner of the cattle. In some cases, some people claimed to be owner of the cattle but could

not prove their ownership of the cattle. Hence, all cases ended up in Final Report.

**Others:** Muktapur PP located at Muktapur village lies in low land area. The climate is very hot in summer and warm during winter. Self in consultation with all my staff (UBC/245 M T Sangma, UBC/127 K P Hajong, UBC/175 E Biam, UBC/295 B Ch Marak, D/C Dapmon Myrchiang and OPR Donbok Kharjahrin) decided to contribute for construction of a swimming pool cum water storage tank for fire fighting at Muktapur PP. 


