Jeon, 2014 october jani 24 tariko Savelife Foundation aro sakgipin V/s union of India aro Sakgipinrangni mamlani writ Petetion (Civil) No. 235 of 2012-o, Hon'ble Supreme Court-ni rai on'gimin gita, Union Legisture-ni chu'onga gita niamrangko tarikujana kingking a'gital dakchakaniko on'giparangna che'chakaniko on'china gita Ma'mong sorkari ge'etaniko on'aha.

Aro jeon, Ma'mong sorkari namgipa a'gital dakchakaniko on'giparang ramao a'sel ong'aniko man'giparangna dakchakaniko ba uamangko jokatna kam ka'engon, uamangna che'chakna nanganirangko ra'chakaha aro indaken Ma'mong sorkari hospitalna, pulis-rangna aro gipin bilo gnanggiprangna, namgiupa a'gital dakchakaniko on'gipa manderang (Good Samaritans)-na che'chakaniko on'china gita ka'mao ja'rikna nanggnirangko ui'ataha :-

1. (1)A'sel ong'ram a'damo donggipa ba namgipa a'gital mande dakchakaniko on'gipa, a'sel ong'aniko mikrontangchi nkgipa manderang, ua saknaa man'gipa mandeko sepangbatgipa hospitalona rimangon, ua dakchakgipa mandeko ba a'gital dakchakaniko on'gipa mandeko, a'sel ong'chakram biapko rongtale agane on'ani ja'manode rang'san uamangko re'angpilna watna nanga aro mamingkoba uamango sing'dapna nanganirangko dakna nangjawa.
- (2) Gipin manderangkoba a'sel ong'a man'gipa mandeko dakchakna ong'katchina gita A'dok Sorkarini nangnikani gita, bilo gnanggipa manderang dakchakgipa mandena ba a'gital mande dakchakgipa (Good Samaritan)-na, uamangni nama kamna krae boksis-rangko on'pilskana nanga.
- (3) Dakchakgipa mande ba a'gital dakchakgipa (Good Samaritans)-ko maming dakeba dosi daggipa ne chanjawa.
- (4) Dakchakgipa mande ba a'gital dakchakgipa (Good Samaritans), jean ramao a'sel ong'anko nike pulis-na ba Emergency Service-na ui'atachim, uamangni bimingrangko mikkang parak ba phone ka'e ka'eba uamangni gimin chu'gimik ui'atanirangko parakchina drana man'jawa.
- (5) A'gital dakchakaniko on'gipa (Good Samaritan)-ni bidingo u'ina nanggnirang jedake bimung aro phone number-rangko, unbaksa hospitalo on'gipa Medico Legal case(MLC) form-o parakaniko ba gapataniko dakani uamangni skaosa pangchakaigen aro draani dongna nangjawa.

(6) Sorkario kam ka'giparang jemangan dakchakaniko on'gipa mande ba a'gital mande dakchakaniko on'gipa (Good Samaritan)-ni biming aro gipin ui'ana nanganirangko parakchina draachim, Sorkari uamangni kosako raka ja'ku de'aniko dakgen.

(7) Jensalo, dakchakgipa mande ba a'gital mande dakchakaniko on'gipa (Good Samaritan) an'tangan a'sel ong'ako nkgipa ong'achim aro jekon pulis ba kachakrio mokordoma chalaiano porika ka'e niani ba sing'sanmdianiko dakna nangao ga'akachim, indakgipa dakchakgipa mandeko ba a'gtal namgipa dakchakaniko on'gipa mande (Good samaritan)-ko changsasan porikka ra'na nangaigen aro dakchakaniko on'gipa mande ba a'gital namgipa dakchakaniko on'gipa mande (good Samaritan) neng'nikaniko man'jana gita A'dok Sorkari Standard Operating procedure-rangko tarina nanggen.

(8) Code of Criminal Procedure 1973-ni section 284-ni ning'ao ge'etaniko on'gimin gita, janapgimin Code-ni Section 296-o pangchakenba sing'sandianiko dakgen aro iani apan ui'ataniko man'ani sal kolatchini gisepon Standard Operating Procedure-rangko tarina nanggen.

(9) Dakchakgipa mande ba a'gital dakchakaniko on'gipa mande aro unbaksana manderang jemangkon kosako ja'rikna nanggni (i)-o janapachim, aro jemangan a'sel ong'aniko mikrontangchi nikachim, uamangna neng'nikrangko man'anioni chel'chakna ba chel'chakaniko on'a gita sing'sandimiting somoio ba porika ra'mitting somoio video conferencing-ko jakkalna nanggen.

(10) Pt. Parmanand Katara Vs union of India aro gipinrang (1989) 4 SCC 286-o hon'ble Supreme Court-ni rai on'aniu pangchakenba Ministry of helath and Family Welfare pilak segatgimin Sorkarini ba Saniba Chalaigipa Hospitalna dakchakgipa mandeko ba a'gital dakchakaniko on'gipa mande (Good Samaritan)-ko, a'selo ga'ake saknaa man'gipa mandeni ma'drang mahari ong'jaskalde, saknaa man'gipa mandeko sana bananio koros nanganina ba rimnapanina tangka gamna nanganiko gamchina agana nangjawa aro saknaa man'gipa mandeko rang'sanan sana nanggen ine ja'rikgniko ui'atana nanga.

(11) Nangmotgipa somoirango, jekai ramao a'sel ong'anirango jeon sangipa (Doctor)-ni simsaniko aro nirokanik nangachim, unomiting doctor an'tangni dakna nanggniko jechakode ba kam ka'gija namrengode ua Indian Medical council (Professional Conduct, Etiquette ba Ethics) Regulation, 2002-o donggipa Odhai 7-ni gita " Professional Misconduct"-o ga'akegen aro ua doctor-ni kosako ia tarigimin niamni Odhai 8-o gnganggipako ra'e nanga ja'ku de'aniko dakgen.

(12) Pilak hospitalrangan napchakram cholgugani nikrangao, 'Dakchakgipa mandeko ba A'gital dakchakaniko on'gipa (Good Samaritan)-ko sing'sandina rakkijawa ba uamangko saknaa man'gipako sana banani koros-na tangka paisako gamatjawa ba dabijawa' ine ra'chakgiminko Hindi-chi, English-chi aro a'doktango ba joltango agangipa ku'sikchi see chapa ka'e tape dona nanggen.

(13) Dakchakgipa mande ba a'gital namgipa dakchakaniko on'gipa (Good Samaritan) nangnika ong'ode, hospitalo, Ua namgipa Samaritan-an saknaa man'gipa mandeko hospitalona ra'bagipa aro a'sel ong'a biapo dakchakgipa ine ra'chakan baksana mitelpilniko A'dok Sorkarini Standard Format-o tarina nanggen aro uandake A'dokni pilak hospitalrangan indake dakchakniko on'gipa on'giparangna ba a'gital mande namgipa dakchakaniko on'gipana Sorkari ong'a ine nikanio, dakchakanina mitelpilskaaniko mesokna gita boksiko on'pilskana ui'ataniko on'ana nanggen.

(14) Pilak Sorkarich ba an'tangmangchi chalaigipa hospitalrangan, ia ja'rikna aro dakna nanggnirangko rang'sanan chu'sokatna nanggen aro ia ge'etanirangko ja'rikjagenchim ong'ode uamangni kosako bil on'gimin manderangchi nanga gita ja'ku de'aniko dakgen.

(15) Ia ja'rikna nanggnirangko chitti baksa ia ui'atani Gazette Copy-ko on'chapatenba Ma'mong Sorkari aro A'dok Sorkari an'tangtangni bilni ning'o donggipa pilak hospital-rangna aro Institute-rangna on'a nanggen aro iarangko tik bewalo ja'rikanirangkoba nina nanggen aro Ministry of Health and Family Welfare aro Ministry of Road Transport and Highways a'songni aro a'dokni songbatrango unbaksana electronic media-o ia ja'rikna nanggnirangni bidingo pilak manderangna ui'atna ba advertisement-rangko chapa ka'na nanggen.

(16) Motor Vehicle Act 1988 ( 59 of 1988)-ni Section 134-ni ning'ao janappgimin ja'rikna nanggnirangara ramao a'sel ong'anio gari chalaigipani dakna nanggnirango maming dakeba nangeani dongjawa.
