

In compliance with the Order of the Hon'ble High Court of Meghalaya in WA No. 53 of 2017 / MC (WA) No. 50 of 2017, the children of Non-Gazetted Police Personnel are not given bonus marks. The candidates will be selected from the merit lists for appointment to the posts as per reservation policy of the Government of Meghalaya. The Select Lists of candidates will be published in due course after obtaining the approval of the Government.

As per orders of the Government, the recruitment process for the post of Unarmed Branch Sub-Inspector (UBSI) has been cancelled as the outsourcing agency has reported detection of technical flaw due to programme failure while correcting the OMR Sheets and allotment of marks for the post. The recruitment for 120 posts of UBSI will be re-conducted. Further, announcement regarding recruitment for the posts of UBSI will be made in due course.

All candidates are hereby informed that their candidatures are provisional and subject to the outcome of the case pending in the Hon'ble High Court of Meghalaya in WA No. 53 of 2017 / MC (WA) No. 50 of 2017. The declaration of result shall not confer any additional right to any person.
