**CID CIRCULAR NO. 2 DATED 27.02.2013**

Sub : **Violation of Human Rights**

The attention of the Superintendents of Police is invited to the observation of the National Human Rights Commission (NHRC) in its Letter No. 09.12.37/DR (L)/2010 dated, 07<sup>th</sup> December, 2010 that in a number of cases of Human Rights Violations, the punishment awarded to the delinquent officers in the disciplinary proceedings is not commensurate with the gravity of the offence/lapses on their part. There are also instances where no departmental action is taken against the delinquent police officials, while in some of the cases, a mere warning is issued or an adverse entry is ordered in the disciplinary proceedings.

All Superintendents of Police and Commandants of the armed Battalions are instructed to take necessary steps to ensure that punishment awarded in all such cases is commensurate with the gravity of misconduct of the official concerned.


