## CIRCULAR NO- 30/2010

A copy of Maithri Hand Book of Andhra Pradesh Police was sent to District SPs for their guidance vide this office letter no. MG.VI-22/2006/2 dated 15<sup>th</sup> May, 2006 (copy enclosed). The above mentioned Hand Book contained details of the functioning of Citizens' Committees in Andhra Pradesh

Subsequently, vide letter No. MG.VI-22/2006/3 dt 23/5/2006 (copy enclosed) the Superintendents were asked to use the Maithri Hand Book as guidelines for setting up and operationalising this Citizen' Committee. Superintendents of Police were again asked vide letter No MG.VI-22/2006/9 dt 8/2/2007 (copy enclosed) to follow the Maithri hand Book with modifications, wherever considered necessary. The same was followed up with another letter vide No. MG/VI-22/2006/5-A, dated 31.7.2006 (copy enclosed) directing Superintendents of Police to speed up the process of setting up the Citizens' Committees and to submit monthly reports indicating progress of setting up and operationalising the Citizen' Committees. But inspite of repeated reminders, Superintendents of Police have not considered it necessary to submit monthly reports indicating the progress in this regard

In order to strengthen the Police Public partnership, urgent steps should be taken to set up the Citizen' Committees at District/Sub-Division (where post of SDPO exists)/Police Station level and the same should be made functional within a period of three month.

Monthly reports indicating action taken in this regard must be submitted to this Office regularly.
