CIRCULAR NO 9/2013

It has been observed that senior officers invariably return to headquarters (Shillong) on the same day after visiting outstation units for inspections, conducting enquiries, investigation and supervision of serious crimes and disturbances. While it is possible that the specific purpose for which the tour was undertaken may have been accomplished, visits to outstation units should invariably include at least a night halt, even though the distance between the outstation units and the headquarters may not be too large. This would facilitate closer interaction with the officers and staff at the unit, resulting in greater awareness of the functioning of the unit and the grievances, if any, of the staff posted there.

Rule 54 of the Assam Police Manual (Part-I) clearly stipulates the time to be spent on tour by supervisory officers and they are directed to go through the provisions of the Rule and scrupulously adhere to them in the larger interest of obtaining a better understanding of the functioning of the outstation units.

Meetings with local leaders and the general public during visits to outstation units are recommended to obtain their perception on the functioning of the outstation units.
