As instance has come to my notice where an Investigating Officer of East Khasi Hills District had submitted a false report to the Learned Court of C.J.M., Shillong. This was detected by the Hon'ble High Court during the hearing of the Bail Petition of the accused of an assault case on 20.8.2014. On perusal of the Case Diaries, the Hon'ble Court found an entry dated 11.8.2014 to the effect that the victim was admitted at Hospital and was in a critical condition, while in fact the said victim was already discharged from the Hospital on 01.8.2014. This is a serious lapse and dereliction of duty on the part of the concerned investigating officer. However, taking a lenient view, the Hon'ble High Court has warned the said Investigating Officer not to repeat such lapses in future.

All District Superintendents of Police are hereby directed to ensure that the Supervisory Officers conduct supervision of cases at regular intervals in compliance of instructions issued from time to time and also as prescribed in Rule-6 of Assam Police Manual (Part-V). Supervisory officers must also ensure that replies to the Hon'ble Courts are not at variance with facts outlined in the Case Diaries as it would be construed as providing misleading information to the Court and invite stern action including departmental action.
