The tender will be received upto 1200 Hrs of the **13th July 2017** and will be opened on the same day at 12:30 Hrs in the Office Chamber of the Superintendent of Police East Khasi Hills, Shillong. Tenderers or their authorized representative may remain present at the time of opening of tender. Tender received after 1200 Hrs of **13th July 2017** by hand or by post will be rejected.


Tender must be accompanied by:-

1. Affixing non-refundable Court Fee Stamp of Rs.25/- (Rupees Twenty-Five) only.

Earnest Money in the form of Cross Bank Draft or deposit to call an amount of Rs.5000/- (Rupees Five Thousand) only be made payable to the Superintendent of Police, East Khasi Hills, Shillong at any Nationalized Bank. The same will be returned to the party concerned as soon as the deal is finalized.
3. The Condemned Article can be inspected on any working day in between 10 AM to 4 PM in the Police Reserve Shillong.
4. The rate quoted should not be less than Rs.25,000/- (Rupees twenty Five Thousand) only.
5. The highest bidder will have to deposit the full amount to the undersigned on the spot and will have to remove the articles on the same day at their own expense. The undersigned will not be responsible for any loss / damage or article if the same are not removed on the date of auction.
