## SHORT TENDER NOTICE

Sealed tender are invited from bonafide, established, reputed manufacturers and registered reputed intending firms and supplier (s) for entering into rate contract for setting up of CCTV for SA Games from  $\frac{5}{02}/16$  to  $\frac{16}{2}/16$  on hire basis as per venue details.

- 1. The Tender should be in 2 (Two) Bids i.e (1) Technical Bid and (2) Price Bid. Tenderer should submit separate sealed cover for Technical Bid and Price Bid. Tender Opening Committee of the office of the Superintendent of Police, East Khasi Hills, Shillong will open the Technical bid in the presence of the representatives of the tenderers if any. The Technical Bids will be properly evaluated by the Committee and only those quotations/Bids which fully complies to the terms and conditions prescribed in NIT and also the prescribed Technical Specification enclosed with the NIT of this office will be accepted. Price Bids of only those Technical Bids which fully conforms to our required Technical specification will be opened.

## 2. Terms and Conditions:

(a) Items offered must be of reputed companies/manufacturers and are authorised suppliers of the same and should meet minimum Specifications as given in tender and accompanied with catalogues/Brochures/ Warranty/Gurantee and will be received up to 1500 hrs on the <u>21.01.16</u> by hand or by post. These will be opened on the same day at 1500 hrs. Tenderers or their authorized representatives are invited at the time of opening of the tender.

(b) Tenderer must sign all pages of the Bid (Both Technical and Price Bid).

(c) Failure to enclose any documents or any invalid documents will result in automatic rejection.

(d) In case of such rescission by successful bidder, earnest money in full, shall stand forfeited and absolutely be at the disposal of Government without prejudice to any other remedy of action to be taken by Govt. Government shall also be at liberty to recover from the successful Tenderer any extra expenses Government may deem necessary in obtaining the supplies.

(e)Tender/quotation should be addressed to the undersigned by designation and not by name. (f) Hiring basis of CCTV would be on a camera per day basis from 6/02/16 to 16/02/16.

(g) The Tenderer will be responsible for installation and maintenance of the CCTV system for the concerned period and to provide technical personnels round the clock.

(h) Tender should quote for all locations for the mentioned period.
