- 2. Rate quoted for each vehicle in Tender should be written clearly both in figures and in words any overwriting should be duly attested.
- 3. Tender should be addressed to the undersigned by designation and not by name. Sealed envelope containing the Tender must be super scribed by words ' Tender for purchase of Condemned Vehicles" and be sent by registered post Deposited in Tender Box in the office of the Director General of Police, Meghalaya, Shillong.
- 4. The following documents should be attached with Tender, Tender received without the required documents will be summarily rejected.
 - a) Attested copy of Photograph of the Tenderer.

b) Earnest Money at 10% of the bid Money be submitted duly pledged in favour of the Director General, Meghalaya, Shillong.

c) Up-to-date trading License in terms of KHADC Regulation Act to whom ever applicable.
