**OFFICE MEMORANDUM**

**Subject :- Payment of Medical Allowance to re-employed pensioners/employed family pension holders.**

The undersigned is directed to invite reference to this Department's O.M. No.F(PR)-49/2009/1 dated 17<sup>th</sup> September, 2009 relating to the payment of Medical Allowance at a uniform rate of ₹700/- p.m. to all categories of Government employees, including pensioners, family pension holders, AIS Officers, etc. and to state that a doubt has been raised on the admissibility of this allowance to re-employed pensioners/employed family pension holders. To clear such doubt, it is clarified that payment of the Medical Allowance, as in the case of Dearness Allowance, stands suspended if the pensioners/family pension holders are re-employed/employed under the State/Central Government or re-employed/employed/permanently absorbed in the state or central Government's Company, Corporation, Undertaking or Autonomous Body. It shall, however, be revived after the spell of such re-employment/employment.
