Dated Shillong the 3<sup>rd</sup> May, 2016.

No.HPL.35/2011/378 - In exercise of the powers conferred by sub-section (1) of section 21 of the Meghalaya Police Act, 2010 read with the proviso to sub-section (4) of section 29 of the aforesaid Act, the Government of Meghalaya is pleased to make the following amendments to the Office Memorandum No. HPL.35/2011/164 dated 07.09.2012 and Office Memorandum No. HPL.35/2011/344 dated 18.02.2016 as follows:
