**AUCTION BID DRAFT**

Sealed Auction Bid affixing non refundable court fee stamp of Rs.100/- (Rupees one hundred) only are invited from bidders for disposal of the condemned Vehicle No.ML-02-0710 (Water Tender Vehicle) **as per annexure 1**. Auction Bid will be received up to 1200 hrs on the **16-02-2026** and will be opened on the same day at 1400 hrs by the Tender Opening Committee in the office Chamber of Superintendent of Police, (F&ES) Meghalaya, Shillong, in presence of the Auction Tender Committee & the Tenderers or Representatives if any.

**Terms & Conditions:-**

1. Auction bid should be accompanied by Earnest Money of Rs 8,000/- (Rupees eight thousands) only in any of the following form duly pledged in favour of the Superintendent of Police, (F&ES) Meghalaya, Shillong:-
  - (i) Deposit at call
  - (ii) National Saving Certificate
  - (iii) Fixed deposit
2. The Tenderers/Bidders or their representatives/agents must be present during the time of opening of the tenders (authority letter to be produced in case of representatives/agents) Whatever objection is to be raised should be done during the tender opening proceeding. Raising objection after the completion of tender opening proceeding will be treated as null & void and the undersigned is not bound to entertain such objection.
3. Tenderers/Bidders must enclose copy of any latest address proof (Adhar card /Epic/Driving Licensed/ PAN card) along with the tenders.
4. Rate quoted for the Vehicle in Auction Bid should be written clearly both in figures and in words and any overwriting or correction will be rejected.
5. Any bidder quoting higher than the offset/base price will be declare the successful bidder
6. Auction Bid should be addressed to the undersigned by designation and not by name. Sealed envelope containing the Auction bid must be super scribed by words "Auction bid for purchase of Condemned Vehicle" and the tender must be sent by register post or deposited by hand in Auction Box in the office of the Superintendent of Police, (F&ES) Meghalaya, Shillong.
7. The Attested Photograph of the Auction Bidders should be attached with the tender without whom the bid would be rejected.
8. The intending bidders may inspect the condemned Vehicle **at Nongpoh** F&ES Station Campus on any working days from 10.00 hrs to 17.00 hrs and for any query they may contact the Motor Transport Officer, F&ES Headquarters, Shillong accordingly.
9. The successful bidder shall be intimated by a letter of acceptance issued by the undersigned.
10. The accepted price in full will have to be deposited by the successful tenderer within 1 (one) hour to the undersign, else the auction committee will award the bid to the 2<sup>nd</sup> successful bidder and the **vehicle removed at his/her own cost within the date fixed by the Department.**
11. The undersigned will not be held responsible for any loss or damage of the condemned vehicles, **if they are not removed within the specific date.**
12. The Earnest Money of the successful bidder shall be forfeited to Government if he/she fails to deposit the accepted price and lift the vehicle within the date fixed.
13. The Earnest Money of the unsuccessful bidder shall be released after the award of bid to the successful Tenderer.
