Auction Notice

It is hereby notified for information to the general public that there will be a public auction on **05.07.2024** at 1300 hours in the office of the undersigned to dispose off of old condemned furniture and office equipments as per the list enclosed in **Annexure-A**. Sealed Tenders will be received up to **1200 hrs on 05.07.2024** in the office of the undersigned and will be opened on the same day at **1300 hrs** by a Tender Opening Committee. Tenderers or their authorized representatives are invited at the time of opening of the tenders and bidding process. Tenders received after **due date and time fixed** by hand or by post will be summarily rejected.

The terms and condition of the tenders are as follows:-

- 1) The below noted documents should be accomplished with tenders:-
 - a) Earnest money of **Rs. 2,000/-** (Rupees two thousand) only should be pledged in favour of the Superintendent of Police, (F&ES), Meghalaya, Shillong.
 - b) Affix non-refundable court fee stamp of **Rs 25/-** (Rupees twenty five) only.
 - c) Attested copy of valid Trading License of United Khasi & Jaintia Hills and Garo Hills (trading by non-tribal) Regulation, 1954 for tenderers as amended from time to time who are required to obtain such license.
 - d) Attested copy of Schedule tribes/castes certificates from Meghalaya in case of ST/SC tenderers.
 - e) Financial stability certificate from the Nationalized Bank.
 - f) Attested copy of recent passport size photograph of the tenderer should be attached to the tenders.
 - g) Tenderers/bidders must enclose copy of address proof (Aadhar/epic/driving licensce etc) and PAN card along with the tenders.
 - h) An Undertaking should be submitted by the tenderers/bidders stating that, he/she is satisfied with the terms and conditions and agree to abide by the same.
 - i) Attested copy of GST Registration Certificate.
- 2) Tenders should be addressed to the undersigned by designation and not by name. The words "**Tender for auction of Furniture and office equipments**" must be super scribed on the sealed envelope containing the tender.
- 3) The articles can be inspected during office hours on all working days by contacting the Quarter Master of office of the Superintendent of Police, (F&ES), Meghalaya, Shillong.
- 4) The bidding process will be conducted on the day of auction by the auctioning committee.
- 5) The tenderers/bidders or their representatives/agents must be present during the time of opening of the tenders. (authority letter to be produced in case of representatives/agents). Whatever objection is to be raised should be done during the tender opening proceeding. Raising objection after the completion of tender opening proceeding will be treated as null & void and the undersigned not bound to entertain such objections.
- 6) The highest bidder will be given the priority. In the event of the highest bidder failing to deposit the full amount in cash or cheque on the spot, the items will be allowed to the next highest bidder and the earnest money of the highest bidder will be forfeited to the Government.

7) The successful bidder will have to pay the amount in full on the spot and remove the condemned articles immediately from office of the Superintendent of Police, (F&ES), Meghalaya, Shillong at his own cost within **3 (three) days time**. The undersigned will not be held responsible for any loss or damage of articles if they are not removed immediately.

8) Earnest money shall be released to the tenderers as soon as the deal is finalized.

9) The acceptance or rejection of the tender rest finally with the undersigned and reserves the right of rejecting any tender or all the Tenders without assigning any reason thereof.
