## **CORRIGENDUM**

1. With reference to Clause at Sl. No. 4 of the Tender Notice — The clause "Attested Copy of up-to-date Tax Clearance Certificate and up-to-date Professional Tax Clearance Certificate from the concerned Taxation Department should also be furnished along with the Tender" may kindly be read as "up-to-date Professional Tax Clearance Certificate from the concerned Taxation Department should also be furnished along with the Tender". The wording "Attested Copy of up-to-date Tax Clearance Certificate" is deleted as it is no longer applicable as per Income Tax Department circular.

2. With reference to Clause at Sl. No. 12 of the Tender Notice –
The clause "Those tenderers who are authorized Agent/Dealers of the Principal Manufacturers are to submit authorized dealership Certificate"

may kindly be read with the addition as follows:

"Those tenderers who are authorized Agent/Dealers of the Principal Manufacturers/Manufacturers are to submit authorized dealership Certificate or to furnish relevant papers for the same nature of work."

3. In Annexure – 'A' (Specification of Items), the breadth of the Camp cot should be read as 2 feet 6 inches instead of 2 feet 2 inches and the materials may also be read as "MS pipe 1.6 inches diameter heavy quality and deep green painted with ISI marked" instead of "MS pipe 1.6 inches diameter heavy quality and deep green painted".

4. In Annexure - 'B' (List of Battalions/Units and Locations/requirement), Column 4 and

Column 5 is hereby added regarding Camcot and Cotton tape newar requirement.

The last date and time for receipt of sealed tenders is hereby extended up to 12:00 Noon on 20<sup>th</sup> November, 2025, and tenders will be opened on the same day at 1:00 PM.
