4. The Tenderer or their representatives/Agents must be present during the Tender opening along with their Firm's Seal and authority letter in case of representatives/agents. 8. Payment will be paid to the successful Tenderer/Tenderers directly only on the completion of Fabrication and on full and correct receipt of the Vehicles by the Department in good working condtions. Documents / Vouchers / RR Bill etc routed through Banks will not be accepted.

9. In the event of the successful Tenderer, failing to perform his/her part of the Contract to the satisfaction of the Department or disregarding any terms and conditions of this Tender Notice. The successful Tenderer will be liable to any or all of the following actions at the discretion of the AIG (A), Meghalaya, Shillong.

(i) Forfeiture of the Earnest Money. (ii) Making good the loss caused to the Govt. through the liabilities, neglect or delay in complying with the demand. (iii) Cancellation of the Contract without any prior Notice.

10. All losses sustained by the Department / Govt. due to failure, omission or neglect of the successful Tenderer (s) will be realized from his or her Earnest Money and if the recovery from the security deposit is not sufficient the successful Tenderer shall be liable to pay the compensation as shall be fixed by the Department / Govenunent accordingly.

ANNEXURE-'A'

SPECIFICATION FOR FABRICATION OF WATER TANKER 4000 Ltrs CAPACITY ON TATA 407, **4WD CHASSIS**

1) **Tank** :- Semi-elliptic tank. Thickness of the plate should not be less than 3 mm. Three partitions are to he provided at equal distance inside the tank. A Manhole with a cover should he provided at the top so as to enable a person to enter inside the tank. The inside of the tank should be painted with 2 coats anti-rust paint.

2). Pump :- Diesel pump 8HP, 25 meters Head preferably Kirloskar make should be mounted at the rear of the Vehicle. Provision shoud he made that both Suction and Delivery of Water can he operated.

3). Accessories :- 1 (one) no Suction pipe, Foot valve and 2 (two) nos. of Delivery Hoses are to he supplied along with the vehicle.

The Chassis and Cabin of the Tata 407 4WD will he provided by the Department.
