No. HPL 292/2018/6 – The following Notification issued by the Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training, New Delhi is republished for general information:

G.S.R. 197(E)- In exercise of the powers conferred by sub-section (1) of section 3 of the All India Services Act. 1951(61 of 1951), read with sub-rules (1) and (2) of rule 4 of the Indian Police Service(Cadre) Rules, 1954, the Central Government, in consultation with the Government of Assam-Meghalaya, hereby makes the following regulations further to amend the Indian Police Service (Fixation of Cadre Strength) Regulations, 1955, namely:-

- 1. (1) These Regulations may be called the Indian Police Service (Fixation of Cadre Strength) Amendment Regulations, 2018.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Indian Police Service (Fixation of Cadre Strength) Regulations, 1955, in the Schedule, for the heading "Assam-Meghalaya" and the entries relating thereto, the following shall be substituted namely:-
