**NOTIFICATION**

In continuation to this Departments Notification No. HPL/199/2018/15, Dated 14<sup>th</sup> December, 2019,

**Whereas** various inputs/reports have been received from Police Headquarters, Meghalaya, Shillong that a law and order situation still prevails within the State of Meghalaya due to reports of incidents of vandalism, stone pelting and arson in various parts of the State in the past few days having potential threat to public safety; including reports of agitations that may disrupt the public peace and tranquility :

**Whereas**, messaging system like SMS and Whatsapp and social media platforms like Facebook, Twitter and You Tube are likely to be used for spreading of rumours and for the transmission of information through pictures, videos and text that have the potential to cause civil unrest and exacerbate the law and order situation.

**Therefore** in order to prevent the misuse of the above mentioned media to disturb peace and tranquility in the whole State of Meghalaya and for maintaining law and order. I, C.V.D. Diengdoh, Additional Secretary to the Government of Meghalaya, Home (Police) Department do hereby promulgate this notification under the provision of Section 5 (2) of the Indian Telegraph Act 1885, read with the Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017 to prohibit the following types of media for the next 48 (forty eight) hours beginning from 5:00 PM on 16<sup>th</sup> December, 2019 in the entire State of Meghalaya.

- (i) SMS of all Mobile Service Providers may be allowed to resume w.e.f. 5:00 PM of 16<sup>th</sup> December 2019, provided that maximum number of outgoing messages are restricted to a total of 5(five) in a day, excluding all online transactions requiring OTPs.
- (ii) Mobile Internet / Data Services of all Mobile Services Providers.

Violation of this promulgation will be punishable under section 188 IPC and also under the relevant provisions of the Indian Telegraph Act, 1885.
