OFFICE ORDER

NOTICE INVITING TENDER

Sealed tender affixing non-refundable court fee stamp of Rs. 100/- (Rupees hundred) only under 2 (two) bid system (technical and financial) are invited from reputed firms for **Supply, delivery and Installation of Digital Display Board** for CCTNS, SCRB, Office of the Inspector General of Police, CID, Shillong. The tender should be submitted on or before **2nd September 2026** and the tender will be opened on the same day at @ **3:30 PM** for technical evaluation.

SPECIFICATIONS DETAILS:

Display & Performance:

Tender details and Requirements:-

1. GST registration Certificate along with latest GSTR-3 files returns.
2. PAN (Permanent Account Number) details of the bidder.
3. Income tax returns along with Audited.
4. Earnest Money Deposit to be submitted physically in the Office of the Inspector General of Police, CID, Shillong.
5. Dealership/ Distributorship certificates.
6. Technical specifications of items to be supplied.
7. Operation Manual.
8. Professional clearance tax certificate.
9. Trading License for non-tribals from KHADC as mandated by District Council Affairs department (DCA.36/91/323 dt: 24.06.2015) should be submitted to the Tendering Authority within 15 (fifteen) days before the allotment of works.
10. Scheduled Tribe certificate from Meghalaya for tribal bidders.
11. Attested copy of Photograph of the Tenderer.
12. Balance sheet for last 3 financial years (2023-24, 2024-25 & 2025-26).
13. All Bidders must submit earnest money of the amount of Rs. 10,000 in the shape of Bank Draft from any scheduled bank in favour of the Office of the Inspector General of Police (CID), Meghalaya, Shillong payable at Shillong. The EMD of successful bidder will be converted into security till complete supply is made and will be refunded without any interest. The EMD of unsuccessful tenderer will be returned after completion of tender process. No tender will be entertained in the absence of EMD.

Terms and Conditions: -

1. The bidder must be a registered legal entity in India.
2. Bids are to be submitted with complete details/ work specifications for specific item bid by the bidder.
3. Rates must be quoted inclusive of all taxes, freight of Railway and destination etc.
4. The bidder should submit an affidavit declaring that they have not been Blacklisted by any State/Central Government/Government department/Ministry/State/District/PSU etc. in India or similar agencies globally for corrupt, fraudulent or any other unethical business practices or for any other reasons and Directors/ Owners/Proprietors and officers have not been convicted of any criminal conduct or the making of false statements or misinterpretations ever.
5. The Bidder should submit the authorization of its OEM / Dealer/ Distributer for item to be supplied. The same should also be notarized on Rs.100 stamp paper with OEM/Dealer/Distributer for the supply of quoted product/ item.
6. The bidder must be engaged in the business of similar related works involving supply and installation of IT hardware /related equipment in any Indian Government department/Ministry/State/District for a minimum period of 5 years as on date of bid submission.
7. The bidder should submit technical specifications of items to be supplied along with all supporting documents of the item/ equipment with warranty details and complete technical details to be attached before the closing date.
8. Bidder should have a valid ISO 9001, ISO 14001, ISO 45001, ISO 10006 and other relevant certificates.
9. The supply of the above noted hardware will be done after the inspection of Sample.
10. Payment will be made only after successful completion of the work as per specifications mentioned accompanying along with the completion Report and Satisfactory Report duly authenticated by the Superintendent of Police, SCRB, Meghalaya, Shillong.
11. Once the rates offered in the Tenders are accepted, no enhancement of rates will be allowed under any circumstances, and the successful bidder will be liable to supply at the rates accepted by the authority concerned. Failure to supply at the accepted rates within 15 (Fifteen) days from the date of receiving the Work Order will entail the offer being cancelled and the security money will be forfeited by the Government.
12. It is mandatory that supply of the above hardware to be started within 7 days from the date of issue of supply order after the inspection of sample by State Technical Infrastructure Committee (STIC), otherwise penalty of late delivery @ 1% of the total cost will be imposed per week.
13. An undertaking should be furnished so that the supply/work will be done by the contractor/tenderer himself/herself.
14. Tender will be opened even if there is participation of only 2 (Two) bidders.
15. The rates should clearly mention both in terms of words and figures inclusive of all taxes and delivery and warranty service of items should be at the SCRB, Police Headquarters, Meghalaya, Shillong. No overwriting will be entertained.
16. In case if the date of opening of the tender happens to be a Holiday, the Tender will be opened on the next working day at the same time and hour.
17. The Office of the Inspector General of Police (CID) Meghalaya, Shillong reserves the right to cancel the tender, reject all or any tender without assigning any reason.
