ADVERTISEMENT

Application in the prescribed PRINTED Application FORM which will be ready at the eleven district SP offices/Police Reserve are invited from candidates both male and female who are permanent residents of Meghalaya to fill up 120 (one hundred and twenty) (111 male and 9 female) vacancies in the Armed Branch Sub-Inspector of Police (ABSI) for the **Special Forces-10 (SF-10)** in the scale of pay of Rs. 14100-350-16550-EB-460-20690-620-27510 P.M. as admissible under the Rules from time to time plus other allowances and special allowances. Application forms will be available with effect from 1st March 2014 onwards, through offices of all District Superintendents of Police and Commandants of MLP Battalions and Principal, PTS Mawroh Shillong on payment of Rs. 50/- (Rupees Fifty Only).

- 1. The last date for receipt of application is 1st April, 2014.
- 2. Applications received after the last date will not be entertained.
- 3. Only one application per candidate will be allowed.
- 4. On the spot temporary admit cards having names of candidates, post applied for and dates and venue of recruitment will be given to the candidates at the time of submission of the application forms. These temporary admit cards will be used for the pet. Final admit cards with names of candidates, post applied for, dates and venue of written test will be distributed/issued to the candidates immediately after scrutinising and scanning of application forms and generation of admit cards.
- 5. Recruitment process for PMT and PET shall take place only at 2nd Battalion, MLP Goeragre and at 1st Battalion, MLP Mawiong for which candidates will have to indicate their choice at the time of applying. Written tests venue will be intimated later. Personal interviews will be conducted in PTS Shillong and dates will be indicated later.
- 6. Incomplete and/or defective applications will be rejected summarily.
- 7. Candidates whose application forms are rejected will have to sign in the rejection register and their application forms will be kept at the receiving centres.

- 8. The training, duties and responsibilities of the commandos/constables of the SF 10 are high risk and strenuous which would need specialized training and equipment in the chosen field of operation like jungle warfare, urban warfare, controlling riots and disaster management and mitigation. Candidates who cannot keep up to the conditions above need not apply.
- 9. The application form should be submitted along with attested copies of the following:
 - i. 4 (four) recent passport size photographs.
 - ii. S.T./ S.C. Certificate for S.T./ S.C. candidates as applicable.
 - iii. Age certificate as per HSLC/SSLC Certificates/Admit Cards or their equivalent certificate testifying the date of birth/age.
 - iv. Educational Qualification certificates.
 - vi. Additional qualification, if any.

Please note (Domicile/Residence certificates will be required in doubtful cases at the time of issue of admit cards/or appointment).

10. **ELIGIBILITY**

A. Age:

A candidate should not be less than 21 years and not more than 27 years as on 01.01.2014 with usual relaxation of 5 (five) years in case of candidates belonging to the SC/ST.

Provided that the serving police personnel, who have bachelor's degree, will be given age relaxation of five (5) years in addition to the usual relaxation and will be permitted to appear in the selection test for the post of ABSI. (ie SC/ST candidates 27+5+5 or 37 years and general candidates 27+5 or 32 years)

B. Education Qualification

Minimum educational qualification required is a Bachelor's degree in any stream from a recognized University.

C. Physical standards: -

1. Height

Male Female

i. 162 Cms for SC/ST 157 Cms for SC/STii. 167 Cms for others 160 Cms for others

D. Medical Standard (Male/Female Candidate)

The candidates should be of sound health, free from defect/deformity/disease. Both eyes should have a vision 6/12 (without glasses) and no colour blindness. No relaxation is allowed to any category of candidates on this count.

A candidate suffering from any of the following physical deformities will be rejected.

1. Knock Knee 2. Flat Foot 3. Night Blindness 4. Defective alignment of eyes

11. TESTS:

Candidates should bring the TEMPORARY ADMIT CARD along with all original documents, testimonials, certificates, etc with them at the time of appearing for the tests as well as during interview.

Further, Candidates should bring the following items with them at the time of appearing for the tests:- BLACK BALL POINT Pens, clip board, short pant, canvas shoes etc.

A. **PRELIMINARY MEASUREMENT TESTS (PMT)**: -On the day of recruitment, candidates will be subjected to preliminary medical tests before they go for physical tests/written tests.

Only those who qualified in the preliminary medical tests will be allowed to appear in the physical tests.

Candidates should bring the temporary admit cards to appear for the PMT. Candidates who do not meet the standards of minimum Height requirement as prescribed will be rejected and further test events of such rejected candidates will not be conducted.

B. REGISTRATION AND AUTHENTICATION OF CANDIDATES: After the Physical Measurement Test, the candidates with temporary admit cards will be required to register themselves at the PET registration counters at the venue of recruitment for biometric data such as Candidates' Finger Prints in respect of each candidate which will be captured by the bio-metric application software.

The candidates' biometric profile will be verified before the Physical Efficiency Test. Only candidates successfully verified will be allowed for Physical Efficiency Test (Race).

C. 10 KM RACE FOR MALE AND 5.5 KM RACE FOR FEMALE CANDIDATES AND TIMING EQUIPMENT: Each Candidate will be issued with a lockable Radio Frequency Identification (RFID) tag, to be tied to his/her leg. The automated timing equipment based on RFID technology will be geared to record start time, finish time and net time of all runners individually. Those who do not finish the race within the minimum prescribed time will be issued a rejection letter and they are not allowed to participate in other subsequent recruitment events. 10 KM race for male candidates will have to be completed within 55 minutes and 5.5 KM race for female candidates will have to be completed within 34 minutes.

Candidates who are not physically fit should not attempt this race. Candidates are advised to consult a physician about their state of health before preparing themselves

to participate in the running test. The Central Recruitment Board will not be responsible for any injury sustained by a candidate during the 10 KM or 5.5 KM race.

D. **PHYSICAL TESTS (Qualifying)** – The scheme of recruitment tests to the post of ABSI and the maximum marks assigned for each event shall be as follows:

TESTS.

Note: There shall be no appeal against disqualification.

E. WRITTEN TESTS: - Only those candidates, who qualify in the physical tests, will be allowed to appear in the written/subsequent tests as follows: -(QUESTIONS AND ANSWERS SHALL BE IN ENGLISH LANGUAGE ONLY AND STANDARD WILL BE as follows:

Paper I – General English including précis writing, essay writing, drafting and English grammar (matriculation standard)	75	120 minutes
Paper II – Elementary mathematics, reasoning and basic science of matriculation standard (multiple choice/ OMR based)	50 (50 questions and each question to carry 1 mark)	60 minutes
Paper III – General knowledge based mainly on Meghalaya	75 (75 questions and each question to carry 1 mark)	75 minutes

All question papers will be set on multiple choice basis and OMR pattern.

Before written tests, candidates who qualified in the PET will be given a Final Admit Card and also uploaded to Meghalaya Police Website for downloading. Only those candidates who qualify in the Physical Efficiency Tests will be allowed to appear at the Written Examination which will be conducted at the time, venue and date to be notified by the Central Recruitment Board. The dates and venues shall be published in Newspapers and on the departmental website.

The result of the written test will be published on the Meghalaya police website and all candidates are also advised to check the results on the notice boards of PTS/ District SPs /Police Reserve Office/COs Battalions Office.

12. **PERSONAL INTERVIEW**: - Full Marks = 50 marks

The Central Selection Board shall decide the number of candidates to be called for interview based on the total number of vacancies.

Candidates who have qualified in the written tests will be required to attend the interviews which will be intimated in due course.

No separate intimation regarding interviews will be sent. It shall be the responsibility of the candidate(s) to check the results and appear for the interview at PTS,Golf Links, Shillong on the dates as notified at the website of MLP.

GENERAL INSTRUCTIONS

- (1) Candidates shall have to appear for Physical Measurement Test (PMT), Physical Endurance Tests (PET) indicated in the Photo Admit Card, Written Examination and Interview on the date and place at their own expenses.
- (2) Only one Photo Admit Card will be issued against one application accepted after scrutiny.
