NOTICE INVITING TENDER

The Superintendent of Police, West Garo Hills, Tura invites Sealed Tenders affixing Non-refundable court fee stamp of Rs. 100/- (Rupees one hundred) only in view of the implementation of the recent G.S.T by the Government of India and change in tax system impacting the rates, for entering into rates contract for supply of Paints/Hardware Material/Welding Gas, as per list enclosed herewith as Annexure-1 during the financial year 2017-18. The tenders will be received in the office of the undersigned upto 28-8-2017 and will be opened on the same day at 1500 hrs. Tenderers or their representatives may remain present at time of opening of the tenders. Tenders received after 1200 Hrs of 28-8-2017 either by post or hand will not be entertained.

TERMS AND CONDITIONS:-

1. The tender should be accompanied with the following Papers/Documents accordingly.
  - i) Attested valid VAT clearance certificate including Tax Identity Number (TIN)
  - ii) Attested up to date professional tax clearance certificate
  - iii) Attested valid copy of Trading Licence from District Council authority in case of Non-Tribal tenderers.
  - iv) P.A.N Card of the firm/individual.
  - v) Attested copy of photograph of the tenderers to be attached along with the tender.
  - vi) All the relevant documents/certificates pertaining to GST rules viz.
    - a) GST Registration Certificate.
    - b) GST rate of the items quoted along with 4 digit HSN (Harmonized System of Nomenclature) Code.
    - c) Any other documents relevant to GST apart from Serial No. (i) and (ii) above.
2. An undertaking stating that the supply will be carried out by the concern firm/supplier himself/herself.
3. Earnest Money Deposit of Rs. 5000/- (Rupees five thousand) only in crossed Bank Draft or call deposit received of any recognised Bank in favour of Superintendent of Police, West Garo Hills, Tura. Tenderer belonging to SC/ST may deposit 50% of the above amount subject to the production of such certificate supporting their claim of the said status.
4. Tender submitting without the above required certificates/documents will not be accepted.
5. Rates should be quoted separately for each item clearly. Any alteration or overwriting should be fully signed by the tenderer.
6. The successful tenderer will have to deposit a sum of Rs. 5000/- (Rupees five thousand) only as security deposit in crossed bank draft or call deposit of any recognized bank in favour of Superintendent of Police, West Garo Hills, Tura.
7. The Articles should be supplied within 24 hours on receipt of the indents failing of which the Articles may be procured from other firm and excess payment if any incurred in the process will be recovered from the successful tenderer.
8. The undersigned is not bound to accept the lowest rate and may reject any or all tenders without any reason thereof.
9. Payments will be made only on submission of bills in duplicate copy and not in cash.
10. The undersigned reserves the right to withhold the payment if any articles supplied is found to be sub standard quality.
11. The earnest money of the successful tenderer will be released as soon as the Security Deposit is

in that case successful tenderer will be bound to supply the Articles at the contract rates under the same terms and conditions of the tender notice.

15. G.S.T deductions if any will be done as per the government norms.

16. The successful tenderer will have to make his own arrangements for delivery of Articles at M.T. Branch of Police Reserve, Tura. No claim for transport charge will on any account will be entertained.
