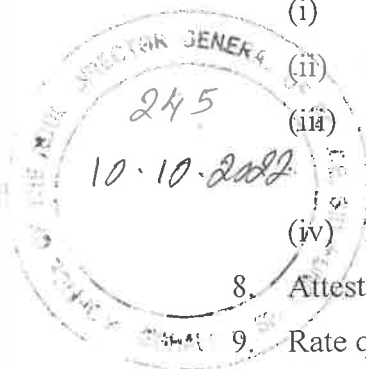
TENDER NOTICE

Sealed Tenders affixing – non-refundable Court Fee Stamp of Rs.100 (Rupees one hundred) only are invited from the Local Firms/Dealers for Stitching of Police Uniforms for the Personnel of SF-10, Meghalaya Police for the year 2022-23 to the Office of the Undersigned which will be received during office hours on or before **25th October, 2022** at **Q – Branch, SF – 10, MPRO Building** and will be opened on the same day at 14:00 hours (2:00Pm) by the Tender Opening Committee in presence of the Tenderers or their Representative(s) if any. Tenders received late by post or by hand beyond the date/ time mentioned above will not be entertained.

The tenderers will have to furnish the following documents:-

1. Earnest Money of **Rs. 5000/- (Rupees Five thousand)** only in the crossed Bank Draft or call deposit received of any recognized Bank in favour of **“The Commandant, Special Force – 10, Meghalaya Police, Golf Link, Shillong”**.
2. Attested copy of Trading license from KHADC for Non-Tribal tenderers.
3. Attested copy of Scheduled Tribe Certificate from Meghalaya for Tribal bidders.
4. Latest Financial Stability Certificate from the Deputy Commissioner, 1st Class Magistrate or any recognized Bank.
5. Attested Copy of latest photograph of the tenderer to be attached along with the tender.
6. An undertaking stating that the Stitching will be carried out by the concern firm/supplier himself/ herself.
7. All relevant documents/ certificates pertaining to GST Rules viz.
 - (i) GST Registration Certificate.
 - (ii) GST Clearance Certificate.
 - (iii) GST rate of the items quoted along with 4 digit HSN (Harmonized System of Nomenclature) Code.
 - (iv) Any other document (s) relevant to GST apart from serial No. (i) and (ii) above.
8. Attested up to date professional tax clearance certificate.
9. Rate quoted for the same should be clearly indicated in the tender.
10. Tenders belonging to SC/ST category may deposit 50% of the above amount subject to the production of such certificate supporting their claim of the said status.

The undersigned reserves the right to reject any or all the Tenders without assigning any reason thereof and does not bind himself to accept the lowest rate. The rate quoted should be inclusive of all taxes and other charges like carriage, etc.



The stitching of Police Uniform should be of good quality. The undersigned or his representative after due inspection will either accept the material stitched or reject the same if found defective or sub-standard and the same will have to be replaced by the supplier(s), and no extra charges on this account will be entertained.
