Tenders will be opened on the same day ie, **the 28th November, 2022 at 12.00 Noon**. Any tender received after due date will be rejected. The rates quoted should clearly be mentioned both in words & figures inclusive of GST. And no overwriting will be entertained.

Terms and Conditions

1. Tender must accompanied with:-

- (a) A Copy of GST Registration/Clearance to be enclosed.
 - (b) Attested copies of valid Trading License in terms of KHADC for Non-Tribals (regulation Act 1954) who are required to obtain such license should be enclosed and a scheduled tribe certificate from Meghalaya in case of tribals (**Certificate must be issued by competent authority of the state of Meghalaya only**)
 - (c) Attested copy of Photograph of the Tenderer should be submitted alongwith Tender
 - (d) An Undertaking should be furnished that the supply/work will be done by the contractor /Tenderer.
 - (e) Latest financial stability Certificate from the Deputy Commissioner 1st Class Magistrate or of a Schedule Bank certifying that the firm/Supplier is capable to undertake the supply should be submitted alongwith the tender.
 - (F) Attested copy of upto date Professional Tax Clearance Certificate should be enclosed.
 - (g) Tender must be accompanied by earnest money @ Rs. 5000/- (Rupees five thousand) only for both Tribals and Non-Tribals
 - (h) Successful Tender will have to deposit Security Money (**2% for Non-tribal & 5% Tribal**).
 - (i) Successful Tender will have to sign a Contract Agreement.
2. The successful Tenderers shall be intimated and a letter of acceptance will be issued by the undersigned.
3. The Earnest Money of the successful/ unsuccessful Tenderer shall be released after the award of Tender to the successful Tenderer.
