Scaled auction bid affixing **Non Refundable Court Fee Stamp** of Rs.25/- (Rupees Twenty Five) only, are invited from interested bidders for auction/disposal of condemn **Fire Fighting Rescue Equipments and Accessories** etc. auction bid will be received up to 12.00_hrs. on 20th Dec, 2024 and will be opened on the same day at 14.00 hrs by the auction bid opening committee of the office of the undersigned in the presence of the tenderers / bidders or their **authorized representatives** and to be remain present during the time of **opening of auction bid**. Any auction bid / tenders either by hand or by post after 12.00 Hrs will not be entertained.

1. Auction bid should be addressed to **the undersigned by designation not by name**. The word **“Auction Bid for disposal of condemns fire fighting and rescue equipments”** must be super scribe on the sealed envelope.
2. Rates quoted in the Auction Bid should be written clearly in **figured and in words**. Any correction or overwriting in the **auction bid documents will be rejected**.
3. Removal of the **auctions items** shall be done solely by the auction bidders themselves and should be completed within the stipulated time.
4. Auction bid below the base price (if any) for disposal of the condemn items will not be entertained, **since the base price has not been fixed, hence the highest bidders will be declared as the winner of the auction bids / tenders**.
5. The following documents should be attached with the Auction Bids / Tenders:
 - a) **Earnest money of rupees 5000/-** in the form **Cross Bank Draft or Call Deposit** pledge in favour of the Superintendent of Police Fire & Emergency Services, Meghalaya Shillong.
 - b) **Valid trading licenses** (attested copy) in term of the united Khasi & Jaintia Hills and Garo Hills (trading by non tribal) Regulation 1954 for non Tribal's.
 - c) **Recent passport size photograph** (self attested) of the Auction Bidder to be attached, without which the bid stands rejected.
 - d) **Valid ID proof** (attested copy of **Adhaar Card, PAN Card, Driving License & Voting ID etc.**) of the Bidder or their representatives along with the bid documents.
 - e) **Attested copy of ST / SC certificate from Meghalaya in case of ST / SC bidders**.
6. Letter of acceptance shall be issued to the successful **auction bidders / tenderers**.
7. The successful **tenderers / bidders** should remove the **auction items** within a specified period (24 hrs from the date of declaring). The undersigned shall not be responsible for any loss or damage of the articles if the same were not removed within the stipulated time.

8. In the event, of the highest **bidder failing to complete and fulfill** the terms and conditions, the **next highest bidder** will be declared as the winner and the security deposit of the highest bidder will be forfeited to the Government.
9. The Earnest money of the un-successful bidders shall be release soon after the award of the bids to the successful **bidder / tenderer** was finalized.
10. The **intending tenderer / bidder** may inspect the condemn **items for disposal** at the office of the undersigned (Provincial Store F&ES Headquarter Shillong) on any working days during office hours.
11. The Undersigned reserved the right to reject **any or all the tenders** without assigning any reason thereof.
